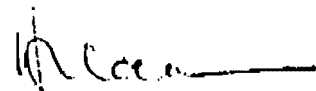
All members of my family are living in USA now our old house in Vietnam is seized by Vietnamese government.

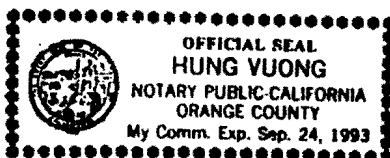
