To be eligible for consideration under ROVR, a principal applicant must have returned to Vietnam, either voluntarily or by the Orderly Repatriation Program (ORP), from October 1, 1995 through June 30, 1996; or, registered to voluntarily repatriate by June 30, 1996 but returned at a later date.

This information will be reviewed by U.S. government officials for a determination of the applicant's eligibility for interview.
