I am currently residing at

Before April 1975, I was a DIRECTOR OF PHYSICAL TRAINING EDUCATION
in the armed forces of the Republic of Vietnam (in the government of the Republic of
Vietnam). After the communists came to power, I was imprisoned in a re-education camp
from (Feb/05/77) to (Feb/01/81)

Because of that experience I have been admitted to the United States on APRIL 19/1996
H.O. 44.592 in accordance with a subprogram of the Orderly Departure Program for
former political
prisoners under a bilateral agreement between Vietnam and the United States. While I
am grateful for the chance to resettle in the United States, my resettlement has been
made extremely difficult because the following unmarried children of mine have been
rejected for resettlement despite the fact that for many years unmarried children were
permitted to
accompany their parents who were former political prisoners

(Children over 21 still left over in Vietnam)

- 1) HOANG THI NGOC TAM (1961) My Daughter, She don't
- 2) HAVE PASSPORT
- 3) HER ADDRESS NOW: CUA HANG DIEN MAY HOANG GIA DINH,
- 4) THI TRAM DINH VAN, HUYEN LAM HA, TINH LAM DONG
VIET-NAM.

Because of the change in policy my wife has had to stay back in Vietnam caus-
ing untold suffering to our family. After long separation due to my imprisonment, our
family now continues to be split at a time when we thought that we could be reunited.

I believe that (his, her, their) status under the eligibility guidelines of the Orderly Departure Program (ODP) is affected by the McCain Amendment of the 1997 Foreign Operation Act which restores eligibility to the unmarried over-21 sons and daughters of the former Vietnamese political prisoners.

I request that ODP check the case(s) according to the case numbers provided above and confirm for me that the son(s) or daughters(s) listed above are eligible and part of the group that ODP is now contacting to invite to interview. If a new letter of introduction has already been sent, I would appreciate knowing the date it was sent and to what address in Vietnam. That will help me ensure it arrives.

I appreciate that your office is busy with many cases, but my family and I are equally anxious to ensure that the case of our children be reconsidered under the new law before their eligibility expires.

On behalf of my family, I thank you for your help in this matter.
