Before April, 1975, I was a Rank Captain, Military Unit Logistics Department in the Armed Forces of the Republic of Viet Nam. After the Communists came to power, I was imprisoned in a re-education camp from April 30, 1975 to July 17, 1980 at Camp Long Giao, Camp Hocmon, and Camp Z 30D Ham Tan.

Because of that experience I have been admitted to the United State on July 5, 1995, in accordance with sub-program of the O.D.P program for former political prisoners under a bilateral agreement between Vietnam and the United State. While I am grateful for the chance to resettle in the U. S. , my resettlement has been made extremely difficult on account of the fact that the following unmarried children of mine have been rejected for resettlement despite the fact that for many years the unmarried children were permitted to accompany their parents who were former political prisoners. These children's names are:

1. DUNG MANH HOANG, Date of birth August 13, 1957
2. DUY MANH HOANG, Date of birth September 23, 1964

Because of that fact my children have had to stay in Vietnam causing untold suffering to our family. After long separation due to my imprisonment, our family is now futher split up at time when we thought that we could be reunited.


