Previously, I had enlisted into RVN Air Force on May 12th 1959 and just stay in BIÊN HOÀ Air Force Base only A.P.O:3 004 until April 30th 1975

From February 1963 I was permitted to go to USA for attending INSTRUMENT REPAIRMAN course held at Lackland AFB, CHANUTT AFB, OJT at RANDOLPH A.F.B in USA I had graduated this course on December 23th 1963. I get until now the I.B for myself the states of Texas with A.B HUYNH QUỐC TIÊN allied student of air training command signed by Governor of Texas John Connally with service number 2491 V.O.E and ID number 1346 by MAJ. GEN Lackland AFB Texas William A Bell on December 23th 1963 for departure to homeland on flight 561 with special order T.791

From the serious event happened on that until now I have been confronting with the difficult situation so that I can not think a way for feeding my family as well as for earning our living here any more

Therefore I need the I.V, LOIS to register to Government Republic Socialist VN, I call upon your

generosity and humanity to assist my family in emigrating to USA as refugees under the protection and support of O D P according to the spirit of Refugees Act in 1980 in order to check a better way of our living therefore the sake of my children's future





