DEAR SENATOR BOXER:

THANK YOU FOR YOUR LETTER OF JANUARY 25, 1999
CONCERNING THE REFUGEE RESETTLEMENT APPLICATION OF LAM

THI MY LY AND LAM THI MY HUONG, RELATIVES OF YOUR
CONSTITUENT, LAM VAN HOA.

OUR RECORDS SHOW THAT AT THE TIME OF YOUR CONSTITUENT'S
REFUGEE APPLICATION, LAM THI MY LY AND LAM THI MY HUONG
WERE DETERMINED TO BE NOT QUALIFIED FOR REFUGEE
CONSIDERATION BECAUSE THEY COULD NOT ESTABLISH THAT
THEY RESIDED WITH YOUR CONSTITUENT AND THEREFORE COULD
NOT BE CONSIDERED AS PART OF HIS DEPENDENT FAMILY UNIT.

ACCORDING TO DOCUMENTS ATTACHED TO YOUR INQUIRY, THE
APPLICANTS IN THIS CASE ARE THE BENEFICIARIES OF
NON-CURRENT FOURTH PREFERENCE (F4) IMMIGRANT VISA
PETITIONS FILED ON FEBRUARY 12, 1996. BASED ON THE
FILING DATE OF THESE PETITIONS, THE APPLICANTS ARE NOT
ELIGIBLE TO ATTEND AN INTERVIEW AT THIS TIME. VISA
ARE PRESENTLY AVAILABLE FOR APPLICANTS WHOSE FOURTH
PREFERENCE PETITIONS WERE FILED PRIOR TO APRIL 1, 1992,
WHICH IS THE CURRENT CUT-OFF DATE OF THIS CATEGORY OF
VISA. THE PETITIONS ARE BEING STORED AT THE NATIONAL
VISA CENTER (NVC) UNTIL THE APPLICANTS BECOME
ELIGIBLE TO ATTEND A VISA INTERVIEW. PETITIONERS
SHOULD REPORT ANY ADDRESS CHANGES OR OTHER INFORMATION
WHICH MAY AFFECT THE APPLICANTS' ELIGIBILITY FOR A VISA
TO THE NVC AT 32 ROCHESTER AVENUE, PORTSMOUTH, NH
03801-2909.

WE ARE SENDING INFORMATION CONCERNING IMMIGRANT VISA
PROCESSING AND HOW TO KEEP INFORMED OF PETITION CUT-OFF
DATES DIRECTLY TO YOUR CONSTITUENT.

IF YOUR CONSTITUENT BECOMES A NATURALIZED U.S. CITIZEN,
HE SHOULD SEND A COPY OF HIS NATURALIZATION CERTIFICATE
OR PASSPORT TO THE NVC SO THAT THE PETITION CAN BE
UPGRADED TO THE FIRST PREFERENCE CATEGORY. THE
APPLICANTS WOULD THEN BE ELIGIBLE FOR AN IMMIGRANT VISA
INTERVIEW.
