
I BELIEVE THAT THEIR STATUS UNDER THE ELIGIBILITY  
GUIDELINES OF THE ORDERLY DEPARTURE PROGRAM (ODP) IS  
AFFECTED BY THE MCCAIN AMENDMENT OF THE 1997 FOREIGN  
OPERATIONS ACT WHICH RESTORES ELIGIBILITY TO THE UNMARRIED  
OVER-21 SONS AND DAUGHTERS OF THE FORMER VIETNAMESE  
POLITICAL PRISONERS.


