On 7/30/89 the Daily Mercury News of San Jose in California reported that the Assistant to the Secretary of State, Mr. Funseth and his counterpart Mr. Vu Khoan of Vietnam have signed an agreement in which the U.S. agrees to accept all Vietnamese ex-prisoners and current political and military detainees to emigrate to the U.S..

I would like to request that my brother, LE HUU THUONG, captain and my half brother, LE XUAN QUANG, Lt. Col. both were officers in ARVN of the Republic of Vietnam, be permitted to go to the U.S.

This is what I still remember about my two brothers:

LE HUU THUONG : Captain, DOB 3/13/41, serial # 61/107.907, chief reconnaissance Team 36 Phuoc Long Province, Group 67, Unit 101. POW since 9/1/75 when Phuoc Long fell into Communists, being jailed at Xuan Loc, Dong Nai province. Box Z.30 A, Camp C. (Gia Rai), Group 8. His superior: Lt. Col. Nguyen Van Hoang, shot himself on 4/30/75. - 1/70 to 3/70 : attending reconnaissance course in OKINAWA (USAR PACINTS), OPO.96331. His instructors: Col. DUDDY, Commander Mr. Kinner, Mr. Francis, Lt. Col. Air force.

LE XUAN QUANG : Lt. Col. serving at the Vice President's Office. Many times trained in the U.S. He was a graduate from Dalat Military Academy. He was released from Camp in 1987, now residing at 483 NGUYEN KIEM, PHU NHUAN, HOCHIMINH city.

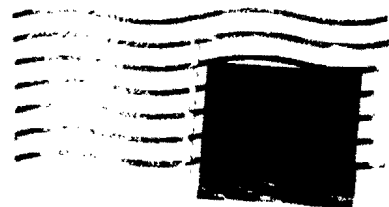
