Chúng tôi được huân chương giải phóng VN và Hoa Kỳ trao thưởng, cho tù & chính-trị được nhập tịch vào nước Mỹ -

Xin bà đừng quên giúp đỡ em, con thiếp đưa cho em chúng tôi được vào đất Mỹ sống một cuộc đời tự do.
