

- ☐ You must obtain a Form G-641 or Form G-639 from the Immigration and Naturalization Service (INS) to verify your U.S. immigration status. Please have the Form G-641 or Form G-639 verified by INS, mark it for inclusion in IV- / / and have INS send it to us.
- ☐ Since/If you are now a U.S. citizen/Permanent Resident Alien, you should file Form I-130 Visa Petition with the Immigration and Naturalization Service (INS) for / . Please mark the Form I-130 for inclusion in file IV- / / .

☒ We need a complete, original, notarized Affidavit of Support (Form I-134) on behalf of your relatives listed above. You must, repeat must, submit evidence of your financial resources, such as verification of employment and wages from your employer, bank statements, or a notarized copy of your recent income tax return. Even if you filed a Form I-134 in the past, we must have a current Affidavit of Support and evidence of your financial resources. Your relative(s) will not be permitted to depart for the United States without these documents. Please respond immediately.


