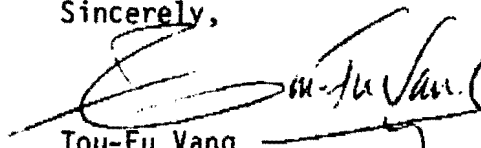
Per your telephoned request, enclosed please find the information regarding Ms. Duc Thang Thi Nguyen, who is residing at
