I would like to tell you a bout my hard situation tha t can only be solved with your help.

In the year 1982, my husband released from the Reeducation Ca mp Ha tay, sent you a n application for req uesting a permission to leave Vietna m under the ODP as a political refugee. The politica l situation here was so strict tha t my husband had to escape abroad by boat on May 1984.

I would like to keep you informed of some more details about my recent situation that could help you to understand my earnest request :

- In september 19, 1984 I was sent for by the Thuanhai Province Police Department in order to proceed with the formalities for an exit visa to the United States. But then the Police were informed that my husband had already escaped to the USA by boat. Therefore I was turned down by the Police because my permanent address in 35-37 Ben Chuong Duong, District 1, HoChiMinh City (my husband's address was in Phanthiet when he applied to The O,D,P)

I was advised that my file would be forwarded to HoChi-Minh City and they asked me to wait for an exit visa there, but so far I have received no ~~news~~ <sup>news</sup> about that.

Would you please be kind to help me ~~find~~ to solve my urgent requests as follows ;

1/ May you put my file IV 045735-30 into your consideration and would you please change the address from 43 Nguyen Thai Hoc Phanthiet to 35-37 Ben Chuong Duong Q1, HoChiMinh City, so that I can legally receive exit visa.

2/ May you enlist a daughter on mine, who was born in 1983, so that she can go with me to the USA, because when my husband applied to the ODP we have'nt given birth to the daughter yet.
