We am writing to you on behalf of the above-referenced case. In September, 1992 we were notified by Rick Warner of RP/RAP that the case had been approved and departure from Vietnam would be within six to seven months from the date of approval. In March, 1993 a Request to Locate and Process Approved Case was again initiated by Mr. Rick Warner because as of that date the final approval had not been granted.

We would like to request that a new medical examination be given Nguyen Huu Phuoc and his family since the previous one expired on July 15, 1993 and that a DAL be issued as soon as possible.

Mr. Nguyen Huu Phuoc was in the re-education camp for 13 years and we would like to see his case handled in a more expeditious manner in order to reunite him with family and loved ones.
