Statement of Mrs. Julie Gay made on 20/5/75 0930 hrs:

On 29-4-75 her husband and daughter left Kien Giang (south coast) on a boat belonging to his wife and loaded with 30 people (Vietnamese personnel of US-Embassy, 10 persons + children) to be disembarked in Phu Quoc. His wife left from the same place at the same time with a US helicopter that landed on an island (Thien Ti) situated near Phu Quoc. Her husband was waiting for her with the boat. They both left with the boat to Phu Quoc where they arrived on 29/4 at 1600. The US ship, scheduled to be off Phu-Quoc in order to take the 30 Vietnamese + husband + wife + dgt, was not there. All of them stayed overnight on the boat.

30.4.75, 16h00, They all left aboard the same boat to Thien-Ti island to take fuel. They arrived (18,00) off this island but could not disembark as there was shooting towards the boat from the island. They left to Hon-Tre island immediately. Arrival Hon-Tre at 22.00 (boat "ancre" 30m des cotes).

Husband disembarked alone in order to see what was going on (from the boat they had seen an helicopter landing). As he was not coming back, a wife's brother disembarked (after 30 mn) and went to the island.

After 10 minutes, the captain of the boat left the boat also. He came back after half an hour saying that he came to know that the husband Arlo Nelson Gay and his wife's brother were captured by the Vietcong troops.

At 23.30, the boat left the island without the two persons captured, destination south coast of Vietnam.

1.05.1975 : The boat arrived at 07.00 in Kien-Giang where all the persons disembarked and escaped wife + daughter remained in Kien-Giang, hiding, until the 18.5.1975.

18.05.1975 : Wife + daughter left Kien-Giang to Saigon.

Some days ago, she came to know through vietnamese marines' wives that her husband and brother were taken by helicopter from Hon-Tre and that they could be on the "Canal No. 13" of the Delta in Camau.
