I, the undersigned Jimmy Nguyen Thuc, U.S. citizenship certificate no. 10860446 (naturalized at Houston on August 8, 1983), currently reside at

On April 30, 1975, my brother, former South Vietnamese Major Nguyen Nhu Nhat - born in 10/22/1936, was sent to Communist re-education camp. From that date to 1983, my brother was imprisoned in North VietNam. Afterwards he was returned to South VietNam where he continued to be kept in prison. In January 1984, my brother was released to be reunited with his family at 94 Thieu Tri, Phuong 10, Phu Nhuan, Ho Chi Minh City. However according to the term of the Release Order, Nhat must be under strict surveillance by Communist authority for at least twelve months.

Immediately after his release, my brother sent me some identification documents, asking me to forward them to the U.S. Embassy at Bangkok (enclosed copies no. 1, 2, 3, and 4). I have not yet had any reply from the Office mentioned when I read about your proposal to have VietNam release their current and former political prisoners for resettlement in the U.S. Therefore I take this opportunity to write you, hoping that you will be able to help my brother and his family, consisted of the following members:

During his twenty years of service in the Republic of VietNam armed forces (from 1955 to 1975), my brother had been sent three times to Malaysia and to The U.S. to study military strategies:

1. Attended the Intelligence course at Malaysia, 1963
2. Attended the Countersurgency course at Fort Bragg, Georgia, 1965
3. Attended the Special Officer Leadership course at Fort Knox, Kentucky, 1969 - 1970

My brother lost all certificates of attendance for these courses, and I have not yet known how to obtain copies of the documents. If they are necessary in proving my brother's ties to the U.S. during the VietNam war and If you do know the addresses of these forts, please let me know.

Telling you how brutal my brother had been treated in prison and how difficult it had been for his family to survive during the period from May 1975 to January 1984 will take pages, and I have already taken a great deal of your precious time. However I would like to add one more thing; that is, to express my agreement with others who had already applauded this proposal. Even though my brother was released from re-education camp after nine long years of imprisonment, the weekly surveillance by Communist authority restricted all of his movements and can put him back to confinement at any time. My brother is living in constant fear. His and his family's freedom lies in the success of this proposal. Therefore on their behalves, I would like to convey their gratitude to you and all others who have been responsible for saving my brother's life and his family's future.

Please inform me of the necessary steps to enlist my brother's case in this program. I appreciate your reading this letter, and I am looking very much forward to hearing from you.


