I believe that (his, her, their) status under the eligibility guidelines of the Orderly Departure Program (ODP) is affected by the new law which restores derivative eligibility to the unmarried over-21 sons and daughters of the former Vietnamese political prisoners.

Please let me know what steps I must take to have ODP reinterview the cases of the names listed above. If any new documentation is needed, please let me know. Also since the new law provides a time period of one year for the reconsideration of the affected cases, how long will it take ODP to recall those cases for reinterview.

I appreciate that your office is busy with many cases, but my family and I are equally anxious to ensure that the case of our children be reconsidered under the new law before their eligibility expires.
