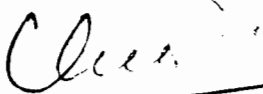

Dear Mr. Pendergrass,

I am writing to you on behalf of my stepson, Hien Minh Nguyen. I believe that his status under the eligibility guidelines of the O.D.P. is affected by the McCain Amendment of the 1997 Foreign Operation Act which restores the eligibility of the unmarried, over twenty one aged children of former Vietnamese political prisoners to immigrate to the United States. I would like to request that the O.D.P. investigate the case according to the number listed above, and confirm that my stepson, Hien Minh Nguyen, is eligible and part of the group that the O.D.P. is contacting for interviews. If a new letter of introduction has been sent, I would appreciate the date and address to which it was sent in Vietnam. This information will help me to insure that the letter will arrive in a timely manner. I appreciate that your office is busy with many cases, but my family and I are equally anxious to insure that the case of our child be reconsidered under the new law before his eligibility expires.

On behalf of my family, I thank you for your help regarding this matter.
