Dear Sirs:

My name is HEN V NGUYEN, a former political prisoner of the Vietnamese Communist regime. I'm currently residing at Tel:

Before April 1975, I was Master Sergeant in Special Police Branch, After the Communist came to power, I was imprisoned in a re-education camp from May 1975 thru September 19th 1980

Because of those experiences, I've been in the USA on August 4th 1995 as refugee in accordance with the subprogram HO 25/771, of the ODP for former political prisoner.

I have 9 adult children, 5 of them have been living with me in the USA, 3 of them have been married and now living in Viet-Nam. There is only one who is still single named:

He was denied in a screening interview for Entry-Visa in Ho-Chi-Minh City, in 1994 because his name was cut out for temporarily from our Family Census Book. The reason is, when he was called up to do his military service in the so-called People-Army of the Socialist Republic of Viet-Nam, he dodged the draft.

Now, according to the amendment 5064 approved the 17th of September 1996, supplementary to the Foreign Appropriation Bill HR 3540 that permit unmarried children of former political prisoner to come to the USA with their parents. I'm making this petition to solicit you to make everything necessary to let my adult child come to live with us.

I hope this petition will be considered very soon. I look forward to hearing from you and your instructions to complete the necessary document and to process anything that comply with the law.

My family and I highly appreciate your help and concerns.
