settling at 2211 Washington Avenue, Fort Worth city, Texas
76110 USA. Formerly I was a political prisoner of the
Vietnam Communist regime.

On September 1994 I had sent a document of my
family to ODP office of USA at Bangkok Thailand to
permit a settlement in USA. My relations in this document

In the LOI date February 6th 1995 of the Embassy of USA
at Bangkok Thailand, there are not names Nguyễn Văn
Phú Quốc and Nguyễn Anh Tuấn because of over 21 old ages.

Moreover, by the poverty make us an unfortunate.
We must wait passports during one year (from September
1994 to October 1995) that is the cause that my son
Nguyễn Thanh Nhân was also over 21 old ages, too.

My application on April 17th 1995, December 14th
1995 and Jan 22nd 1996, I had sent to ODP office
of USA. I hope ODP office reviewing the miserable
situation of three unmarried sons above who accom-
pany with us.

After the interview on January 16th 1996 of

the Delegation of USA at Ho Chi Minh City, we have been admitted in USA on June 25th 1996. We are:

While we're grateful for the change to resettle in USA. My resettlement have been most extremely difficult because because the following unmarried children of mine have been rejected in Vietnam. They are:

1. Nguyễn Văn Phú Quốc' born August 4th 1969
2. Nguyễn Anh Tuấn' - December 27th 1971
3. Nguyễn Thành Nhân - July 2nd 1974

They are the lastest sons in the family, who were supporting a miserable situation and have got passports.

According the Amendment of the refugee law of USA which was promulgated recently, I hope ODP office of USA help me and my family will be reunite together in USA.
