PHAM THI MINH CHAU



Dear Sir,

I have just received your office's letter of February 09rd 1993 concerning the case of my daughter, NGUYEN THI THU-NGUYET.

Basing on this letter, we were advised that NGUYEN THI THU-NGUYET, along with her 3 children was not eligible for entry to the USA accompanying me for the following reasons:

- She has not remained single
- She is not a member of my family.

I would like to declare some matters relating to my daughter, NGUYEN THI THU NGUYET, for your favorable re-consideration.

/1/As for my daughter's single status/:

I do guarantee that, presently, my daughter NGUYEN THI THU-NGUYET is single on the evidence of the following documents:

- In my entry file (IV # 215684) as well as at the Interview, I have presented the copy of the Decree for Recognition of Divorce between PHAM VAN DUC and NGUYEN THI THU NGUYET given by the People's court.

At the request of the ODP Officer in the Interview, I have submitted a copy of Marriage certificate between PHAM VAN DUC and another woman after their above-mentioned Divorce.

- And my Household Registration and the School-Records of her 3 children in support of my Application.

/2/ On my honour, I do guarantee that NGUYEN THI THU NGUYET is my natural daughter and member of my family.

Until Feb 13th 1988, after being released, I returned to live with my daughter's family (THU NGUYET) and she has provided all the financial maintenance assistance since then because of my unemployment.

I do solemnly swear to speak the truth, the whole truth and nothing but the truth.

Would you please kindly re-consider my daughter's case - NGUYEN THI THU NGUYET so that she may be permitted to leave for the USA accompanying me.


