*I am writing on behalf of my children, Thanh Duyen Thi Nguyen, Thanh Huong Zhi Nguyen, and Thanh Son Nguyen. I believe that their status under the eligibility guidelines of the O.D.P. is affected by the McCain Amendment of the 1997 Foreign Operation Act which restores eligibility of the unmarried children over 21 of former Vietnamese political prisoners to immigrate to the United States. I would like to request that the O.D.P. investigate the cases according to the cases numbers listed above, and confirm for me that the son and daughters listed are part of the group that the O.D.P. is contacting to come in for an interview. If a new letter of introduction has been sent, I would appreciate knowing what date and to what address in Vietnam it was sent to. The address and date will help me to insure that it arrives in a timely manner. I appreciate that your office is busy with many cases, but my family and I are equally anxious to insure that the case of our children be reconsidered under the new law before their eligibility expires.*
