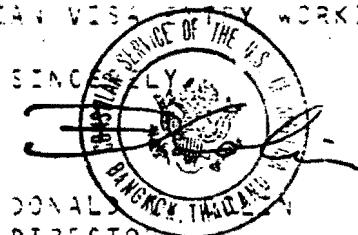

- [✓] Your application to be admitted to the United States under Section 207 of the Immigration and Nationality Act, as amended, as a refugee has not been approved. You have failed to establish that you qualify as a refugee under the provisions of Section 101(a)(42) of the INA.
- [] You have been approved to enter the United States as a parolee under the Public Interest Parole Program initiated by the United States Government in the interest of family reunification. You must have a sponsor who will pay for transportation to the United States and show that he or she has the financial ability and willingness to support you until your status can be adjusted from that of a parolee to that of a permanent resident of the U. S. You will also be given authorization to seek employment once you are in the U. S.
- [] Upon a thorough review it has been determined that you are not eligible for consideration under the Orderly Departure Program. ODP processing criteria does not include cases such as yours, and therefore we are unable to proceed with your case.
