

- I have been soon released from the Reeducation Camp (Suối máu - Biên Hòa) Because I had the disease from my ears.
- I have sent all the necessary documents to the Vietnamese Authority in order to obtain the Exit Permits. These documents had been transmitted to the Vietnamese interior Ministry since october 16, 1989 the order Number is 41.
- I don't have any close relative living in the U.S.A. who could make the request for sponsor to me and my family. So I request your consideration and your help to my case.
- I have submitted my request to the O.D.P. office in Thailand for resettlement in the U.S.A. on April 15th 1990.
- When the Exit permits will be issued to us, I have to inform to your Association for the interference about the Interviewing and the departure for resettlement in the U.S.A.
