the former Vietnamese political prisoners.

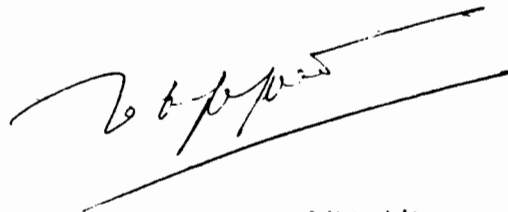
I request that ODP check the case according
