I request that ODP check the case(s) according to the case numbers provided above and confirm for me that the son(s) or daughters(s) listed above are eligible and part of the group that ODP is now contacting to invite to interview. I appreciate that your office is busy with many cases, but my family and I are equally anxious to ensure that the case of our children be reconsidered under the new law before their eligibility expires.
