I request that ODP check the cases according to the case numbers provided above are eligible and part of the group that ODP is now contacting to invite to interview. If a new letter of introduction has already sent, I would appreciate knowing the date it was sent and to what address in Vietnam. That will help me it arrives.

I appreciate that your office is busy with many cases, but my family and I are equally anxious to ensure that the case of my family be reconsidered under new law before their eligibility expires.

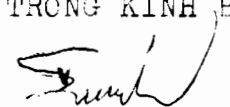
