Dear Sir/Madam,

Ever since after receiving the Entry Permit from the United States government thru the Orderly Departure Program, my parents have been requesting permission from the Vietnamese government to exit the country; unfortunately, their request has been denied.

The Vietnamese government's reason for not allowing my family to leave the country was because my father, who was a colonel in the former South Vietnamese Army, is still being detained in what so-called "Re-education Camp"; and they also refused to let us know when he would be released.

My only dream after becoming a citizen of this country is someday be able to reunite with my family. However, under the present situation my dream is just getting less and less of a reality, and I am feeling more and more helpless as each day goes by.

Therefore, I would like to ask you to convey my wish to the appropriate authority. Realizing that we are not currently having any formal diplomatic relationship with the Vietnamese government, I hope that at least we can appeal to them thru humanitarian channels (both my parents are now fifty-seven years old and my mother is suffering from serious asthma illness which requires better medical attention than presently available in Vietnam.)

While awaiting for your response, please accept my deepest gratitude to you for your assistance in this matter.
