TRAN CAT SON



Dear Sir,

All persons in my family always believed the ^{of} humanitarian of the people and the Government of the United States of America that we shall have occasion for leaving from Viet Nam and refuge in the U.S.A under the ODP.

But having received your letter dated in 12 September 1994, we are very sorried and it is a disaster to my family at your determined, because during 6 years from 1989 to present, my children are not married and only entertained in their wit a day for leaving from Viet Nam for could have reached the liberty. All my sons and daughters are very - unpleasant and distress so that they did not want to continue their life at your refuse which they are not eligible for entry to the United States of America.

Besides, I'm seventy three years old, my wife seventy four, it is needing them often beside for they can help us when we are ill.

Moreover, it based on three principal cases for my children have enough condition for accord by you :

1.- According to the letter send to us dated on 25th July 1989, the Embassy of the United States of America - ODP need : "Your legal spouse and unmarried children are only relatives eligible accompany you to the United States".

2.- My file had been accepted by the US Representative Interview Team in 16 June 1994, did not refuse anyone ; it had only furnished three supplements:

a.- Photocopy of ho khau 1977 ; b.- birth certificate of Tran Cat Lam, Tran Cat Son ; hoc ba of Tran Thi Thu. Those papers were already submitted at the Interview Office in 27 June 1994 ; but unluckily for us that this Interview Troop had been leaving from Viet Nam some day before.

3.- By Two ho khau : one dated 1977, the other 1340/NK3^a ; also their birth certificated. Those documents, evidence justified : Tran-thi-kim-xuyen, Tran-thi-Thu, Tran-cat-Thang, Tran-Cat-Lam and Tran-Cat-Son, are my sons and daughters, and they have been living with us - uninterrupted from their born day till now.

Dear Sir, with your humanitarian, please reconsider our case by accepted my children, who may go with us to the U.S.A because our family are obsess and extreme disarray in life if my children can't enter to the United States of America.

Dear Sir, in awaiting your reconsideration, would you mind accepted here my deep ~~test~~ gratitude and highly appreciated.

Finally, with your humanitarian please save my children's life and the reunion of our family.

It is now, a third request we send you for require your re-consideration about my children, who does not eligible to enter in the United States of America under the ODP.

Your determination in 12 September 1994 noted "the evidence submitted does not satisfactorily establish the claimed relationship between you and your children" may be distort the truth.

- Because my children has their birth certificates and we have two Hộ-khẩu (Attestation family registered), one in 1977 and the recently 1340/NK3a.

- In addition, my wife's name, also my children's name and my name are printed in their certificates and in two Hộ-khẩu.

- Furthermore, my children had to live with us in the same house since their born day till now.

So, it is doubtless, not only satisfactorily establish the claimed relationship between our children and me, but also a intimacy familial between my children and me together.

Moreover, my file has been accepted by the US Representative Interview Team in June 1994, did not refuse anyone, it had only furnished Hộ-khẩu 1977, Khai-sinh of Trần-cát-Lâm, Trần-cát-Sơn and Hộ-c bà of Trần-thị-Thú according to the requirement of the Interview Team. These papers were already submitted at the Interview Office in 27 June 1994, but unluckily for us, this Interview Group has been leaving Vietnam few day before. Then, my file was sending to you - ODP Thailand.

Sir, With your humanitarian, please re-consider our case by accepted my children, who are eligible accompany me for entry to the USA under the ODP.

Please save my children's life and our family reunification.

In awaiting your re-consideration, will you mind accepted here my deepest gratitude. I would also want to have a good information, and I look forward to hearing from you as soon as possible.
