
I believe that her status under the eligibility guidelines of the orderly departure program is affected by the McCain Amendment of the 1997 Foreign Operations Act, which restores eligibility to the over 21 unmarried sons and daughters of the former Vietnamese political prisoners.

I request that O.D.P. check the case according to case number provided above and confirm for me that the person listed above is eligible and part of the group that O.D.P. is now contacting to invite to interview. If a new letter of introduction has already been sent, I would appreciate very much to know the date it was sent as well as the address (in Vietnam) it was sent to. This will assure me about its arrival.

I understand that your office is really busy with many cases, but my family and I are equally anxious to be ensured that my daughter's case is being reconsidered under the new law before her eligibility expires.
