I am writing on behalf of my son, VO TRUNG QUOC THUY, DOB :
Dec 9, 1970, present address 111 Lo D, Chung-cu Co Giang, Phuong
Co Giang, Quan 1, Ho chi Minh, VietNam.

I believe that his status under the eligibility guidelines of
the Orderly Departure Program (ODP) is affected by the Mc Cain
Amendment of the 1997 Foreign Operation Act which restores
eligibility to the unmarried over 21 sons and daughters of the
former Vietnamese political prisoners.

I request that ODP check the case according to the case number
provided above and confirm for me that my son is eligible and
part of the group that ODP is now contacting to invite to interview.
If a new letter of introduction has already been sent, I would
appreciate knowing the date it was sent and to what address in
VietNam. That will help me ensure it arrives.

I appreciate that your office is busy with many cases, but my
family and I are equally anxious to ensure that the case of my
son be reconsidered under the new law before his eligibility
expires.

On behalf of my family, I thank you for your willing help in
this matter.
