Our family were interviewed on December 13, 1995 in Saigon, Vietnam for the departure to the United States, included:

1. Vu Ngoc Duc	myself
2. Le Thi Loan	spouse
3. Vu Thuy An	daughter
4. Vu Tuong Duy	son
5. Vu Tuong Vinh	son
6. Vu Kim Phuong	daughter DOB: 10-13-67, unmarried
7. Vu Quoc Do	son, DOB: 12-30-74, unmarried

We have one more son, Vu Duy Dat who was married, so he did not come to the interview. ODP office has recently notified me that **Vu Kim Phuong** and **Vu Duy Dat** are eligible for the re-interview according to McCain Amendment of the unmarried over 21 children who was denied at the previous interview. I think your office made a mistake of my son name because Vu Duy Dat is married and was not denied by the interviewer. **Vu Quoc Do** is unmarried and was denied by the interviewer on December 13, 1995 in Saigon ,instead, because he still had 17 more days to become 21 at that time.

Vu Kim Phuong and **Vu Quoc Do** are my single over 21 children who really want to join my family in the United States. They are eligible for the McCain Amendment because they are my unmarried over 21 and left-behind children. Now they could not find any job to survive in a running down economy. They are living in a hostile atmosphere because their family claimed refugees in the U.S. We are suffering about this separation deeply. We hope one day the U.S. humanitarian program will reunite us in one family in the U.S. Please give them a chance to be re-interviewed and to join us here.

They are living at **9 Duong Nguyen Du, Thi Xa Rach Gia, Kien Giang, Vietnam** and waiting for your mails.

I believe that (his, her, their) status under the eligibility guidelines of the Orderly Departure Program (ODP) is affected by restoring eligibility to the unmarried over 21 sons and daughters of the former Vietnamese political prisoners.

I request that ODP check the case (s) according to the case numbers and confirm for me that the son(s) or daughter(s) listed above are eligible and part of the group that ODP is now contacting to invite to interview. If a new letter of introduction has already been sent, I would appreciate knowing the date on which it was sent to whom and what address in Vietnam. This will help me ensure its safety.


I appreciate the fact that your office is busy with many cases, but my family and I are equally anxious to ensure that the case of our children be reconsidered under the new law before their eligibility expires.
