I was a former First Lieutenant for the Hoa Thanh Police Department, for Xuyen Hiep, prior to April 30, 1975. After the fall of the South into the North Vietnamese Communist regime, due to my military career, I was sent to the Cay-Lam camp in the Hoa Binh province to be reeducated. While in this camp, I met Second Lieutenant Hung Phi Nguyen who was sent here to serve the time as I was during this period. I received my release on October 11, 1982 while Mr. Hung Phi Nguyen was not on the release list.

I am writing this letter to verify that Mr. Hung Phi Nguyen was in the same prison with me. I also affirm that this is a camp that most of our comrades were held in a lengthy time. I will stand behind my words and take full responsibility for my actions.

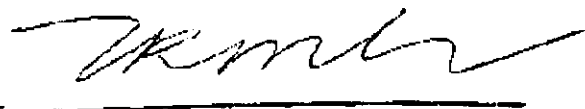

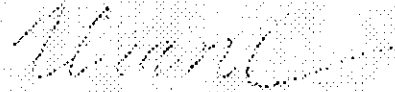
