RE: Response to FVPPA

We have reviewed the two lists submitted by the FVPPA and the following is a breakdown of the action taken on each case. The IV-number for each case is listed if a record was found for that particular applicant. If an LOI or document request was sent, it was mailed to the most current address of the relative in the U.S. which we have on file. If there was no U.S. or third country address on file, the LOI or document request was sent directly to the applicant in Vietnam at the most current address on file. For applicants for whom no record was found we opened a file if there was sufficient information for file creation purposes or sent a questionnaire asking for more information from the applicant or relative. Once these forms are returned, we shall open files and take the appropriate follow-up action required. A specific breakdown of action taken on each case follows. Numbers in parentheses refer to the list numbers of the cases as they appear on the FVPPA lists.
