
Dear Mrs. Khuc:

I received your literature. Thank you. Those of us fortunate to survive our Vietnam experience did so often as a result of the care taken of us by our Vietnamese military comrades. My Third tour of duty as an advisor to the First ARVN Division was marked by a great deal of danger which was overshadowed by daily acts of bravery by my counterparts and incredible kindness shown to me.

I have taken the liberty to copy and send your literature to Mr. Carl White who coordinates an annual dinner celebration of advisors to the Vietnamese Marine Corps. As you can see, they too have not forgotten their old counterparts and will be toasting them on May 5. I am suggesting to Major White that he make some kind of announcement of your organizations aims or perhaps have you speak to the group.

I hope to meet with you within a month's time.

Dear Carl:


I was an adviser in 70-71 for an ARVN infantry battalion of the First ARVN Division working the DMZ, Rockpile, Dong Ha area. I was totally impressed with my counterparts' bravery and ability. Most were killed or taken prisoner during our raid into Laos in 1971: the remainder probably were imprisoned in 1975 when RVN was lost.

I have always wanted to find some way to help their families and recently found an organization here founded to help some of the "re-education" prisoners finally being released and their families in immigrating to the U.S. 80% of these "political prisoners" are former military, majors and above. I am enclosing some of the literature sent to me by their President.

I think that the Association of Advisors to the Vietnamese Marine Corps could play a vital role in assisting our former comrades in arms, particularly in view of the fact that those most reluctant in accepting the "re-education" are the ones held the longest and are now just beginning to be released. In other words, they continued to spit in their captors' eyes.

I'm sure Mrs. Khuc would enjoy meeting with you and even say a few words at your reunion May 5th. I assume I'm still invited as you all have been kind enough to do for the last several years but I have a family vacation in Florida scheduled for that week. I am taking the liberty of forwarding a copy of this letter to Mrs. Khuc.

Dear Mr. Pierce:

I have been active in the last two years in assisting with the immigration through the ODP program of former comrades of mine in the ARVN captured during the Lam Son 719 Operation in Laos in early 1971. I was an advisor to the 2d Regiment, 1st ARVN Division during that operation; I have assisted in getting my friend and close counterpart, Tran Ngoc Hue and family, to the U.S. last November. Both Mr. Hue and I appreciate the hard work the Bangkok Embassy H.O. Team did, and I'm sure we speak for all those who are tasting freedom now in thanking you and the State Department H.O. apparatus for this wonderful program.

I am advised by the two referenced former 2d Regiment soldiers, and I have copies of their paperwork, that they are not eligible for the ODP program "at this time" because they did not "spend 3 or more years in re-education as a result of their association with US policies and programs in Vietnam". Since Mr. Khoa documented that he spent from 1971 to 1976 in a North Vietnam POW Camp, and Mr. Son documented that he spent from 1971 to 1977 in the same status, I'm confused over the insistence that they be "reeducation" inmates rather than POW inmates before being eligible. Confusing all of us is the good fortune of the following captives from "our" Regiment in the identical status as Mr. Khoa and Mr. Son who have happily been embraced by the program;


To our knowledge, none of these men qualify for any other consideration on your form ODP-6(1/92) Deferral Letters dated 7 May on each of the referenced cases.



Dear Mr. Cam,


Thank you for your letter of February 4 which I received March 6.


Please do not lose hope, and do not lose faith in the U.S. Government to do the right thing by you.




The President of the United States of America, authorized by Act of Congress, July 9, 1918, has awarded the Silver Star to

**CAPTAIN TRAN NGOC HUE
ARMY OF THE REPUBLIC OF VIETNAM**

for gallantry in action:

Captain Hue distinguished himself by gallantry in action during the period 31 January to 26 February 1968 while serving as Commanding Officer, 1st Infantry Division Reaction Company, Army of the Republic of Vietnam. On 31 January, enemy forces launched a coordinated mortar, rocket and ground attack on military installations in the city of Hue to include the Hue Citadel Airfield which was being guarded by two United States Marine security guards. Fearlessly moving about the company front, Captain Hue exhorted his men and directed their fire. After rescuing the Marines, Captain Hue proceeded to the Division Headquarters area which was also under ground attack. Captain Hue directed his company against the enemy forces thus relieving pressure on the headquarters and killing many enemies. On 22 February, the Company received orders to reinforce friendly forces engaged in a fierce fight against an enemy battalion. During the ensuing battle, Captain Hue repeatedly subjected himself to fierce fire as he fearlessly trooped the front lines fighting and exhorting his men to aggressively engage the enemy. As a result of his inspiring leadership and unremitting display of battlefield courage throughout this period of prolonged fighting, the company was able to secure a series of resounding victories over a strong and determined enemy. Captain Hue's conspicuous gallantry in action reflects great credit on himself and the Army of the Republic of Vietnam.

Many times he led his company in assaulting the well-fortified enemy positions. He coordinated fire support and maneuvering of his subordinate units. His exemplary leadership and devotion to duty were contributing factors in the overall success of the operation. Captain Hue's heroic actions reflect great credit on himself and the Armed Forces of the Republic of Vietnam.
