Again, we deeply appreciate your kind assistance and support. We hope that you will continue on with your commendable work so the world can keep believing in the existence of freedom and justice.

Dear Madam/Sir

For many years Amnesty International has researched the question of detention without trial for purposes of "re-education" in Viet Nam. On the basis of information provided by you and others we have opened files for your relative(s) or friends(s) and submitted appeals on their behalf to the government of Viet Nam. We have urged the authorities either to charge them with a recognizable criminal offence or to release them unconditionally.

As I am sure you already know, the Vietnamese authorities recently declared two major amnesties to mark the country's National Day in September 1987 and the Lunar New Year in February 1988. Under these amnesties some 6,000 prisoners were reportedly released from "re-education", including some 1,500 held in detention since 1975. Unfortunately, the Vietnamese authorities have not published the names of all the released prisoners, and without reliable information about the individuals we have in our records, it is difficult for Amnesty International to take effective action. We cannot appeal on behalf of people who have already been released but we certainly will continue to appeal to the government on behalf of those still held in detention.

May we ask you therefore, to let us know as soon as possible if you have received news from Viet Nam indicating whether your relative(s) or friend(s) have been released or are still in detention, and to let us have up-to-date information about their current circumstances, state of health, and where they are detained if they have not been released.

This information will help us greatly in our research and in enabling us to define the most appropriate course of action for political prisoners still imprisoned in Viet Nam. Any information you send us will be treated as entirely confidential.
