#### **COMMENTS**

Dear Pam:

Please see attached documentation concerning the case of Nguyen Phi Hung and his family (IV-37454/RF1-2090). As you can see from the attached November 18, 1997 fax from ODP, this case was denied due to a lack of credibility concerning time spent in the reeducation camp.

Following the denial, we sent numerous statements from fellow prisoners who were detained in the same camp at the same time and who attested to the fact that Nguyen Phi Hung was detained at the same time. We assume these statements are in his file with ODP.

We are now sending an attestation dated March 10, 1998, from the Bac Lieu Police Headquarters of the Socialist Republic of Vietnam certifying that Mr. Nguyen Phi Hung was detained in a reeducation camp from May 7, 1975 until December 3, 1982, a period of **7 1/2 years**, which qualifies him for the HO subprogram.

We believe that this new evidence justifies a review of this case. Please let us know.
