**PERMISSION AGREEMENT**  
between  
**United States Catholic Conference**  
and  
**FAMILIES OF VIETNAMESE POLITICAL  
PRISONERS ASSOCIATION (FUPPA)**

This Agreement is by and between the United States Catholic Conference, 3211 4th Street, NE, Washington, DC 20017, a nonprofit District of Columbia corporation exempt from federal taxes under section 501(c) (3) of the Internal Revenue Code ("USCC"), and Families of Vietnamese Political Prisoners Association of VA, Non-Profit ID #1545-0056 ("Owner"), and shall become effective on the date of the last signature below.

Owner and USCC agree as follows:

1. Owner represents that he is the copyright owner of a(n) entitled (hereinafter referred to as "the Work") and warrants and represents that he has the exclusive rights to reproduce, distribute and sell the Work in whole or in part throughout the world, and to permit others to reproduce, distribute and sell the Work in whole or in part throughout the world.
2. Owner grants to USCC the non-exclusive right to reproduce in whole or in part and distribute the Work in works published by USCC in print and digital form throughout the world in perpetuity, commencing on the effective date of this Agreement.
3. Owner warrants and represents that Owner holds the copyright in the Work and the uses made by USCC of the Work as described herein will not violate any right or interest of any person or entity. Owner promises and agrees to hold harmless and defend at his own expense USCC from and against any and all claims, demands, expenses and suits arising from the Work, and from any breach of any of Owner's warranties, representations or obligations contained in this Agreement.
4. Nothing in this Agreement shall be deemed to create an employer-employee, partnership, joint venture or agency relationship between Owner and USCC. Owner warrants and represents that he has full authority to enter into this Agreement and grant the rights to USCC written above. This Agreement contains all the provisions agreed upon by the parties with regard to permission for use of the Work and portions thereof. Any amendment to this Agreement must be in writing and signed by Owner and USCC.
