The processing of the unmarried over-21 sons and daughters of the former political prisoners. Our association and the Vietnamese community believe that ODP should return to its original policy of including (derivative status) the unmarried over-21 sons and daughters in the cases of the political prisoners. We believe that the end of the HO subprogram is not the time to suddenly apply "world wide" standards. The Department of State should reverse its rule on these sons and daughters and allow them to accompany their parents to the United States, which was the policy for most of the life of the program.

The status of the widows of the special lost commandos. Our association has learned that ODP is excluding the widows and children of special commandos who died during the special operations behind enemy lines or died afterwards. We believe that the criteria of the HO subprogram is too restrictive for the families of special commandos. We ask your help in getting ODP to include the widows for the special commandos for resettlement in the United States.

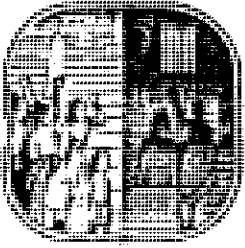
