Điều 595.(a) Tiêu Chuẩn Cho ODP: Trong mục tiêu xét tiêu chuẩn cho ODP dành cho công dân Việt, một ngoại kiều định nghĩa trong phần (b) sẽ được xét là tị nạn vì lý do nhân đạo đặc biệt đối với Hoa Kỳ trong phạm vi của Điều 207 của Sắc Luật Di Trú và Quốc Tịch (8 U.S.C. 1157) và sẽ được nhận định cư vào Hoa Kỳ nếu ngoại kiều ấy hội đủ tiêu chuẩn di dân của Sắc Luật Di Trú và Quốc Tịch (ngoại trừ theo như ấn định bởi điều 207(c)(3) của sắc luật này).

(b) Các ngoại kiều được hưởng quyền lợi này: Ngoại kiều mô tả trong điều khoản này là một ngoại kiều mà --

(1) là con cái của một công dân Việt Nam, và công dân này đã --

(A) bị đưa đi tù cải tạo bởi Chính Quyền Xã Hội Chủ Nghĩa Việt Nam; và

(B) được nhận cho định cư như một người tị nạn theo chương trình ODP vào hay sau ngày 1 tháng 4, 1995;

(2) trên 21 tuổi; và

(3) chưa lập gia đình vào thời điểm cha mẹ được nhận định cư theo chương trình ODP.

(c) Thay thế cho luật hiện hành: Điều luật này sẽ thay thế cho tất cả các điều luật hiện hành.
