Get to the Appropriations Committee staff of both the Senate and the House.

Suggest that they insert language something like the following into the HHS/FSA/ORR FY 1990 appropriation for social services:

"Funds appropriated under this section may be used to provide refugee social services to former inmates of Vietnamese reeducation camps, regardless of whether they have refugee or immigrant status."

- It would cost nothing extra
- It would not work a strain on the system
- It would provide badly needed services, especially employment services

Of the 3,500 immigrants likely this year, most will not need ESL training because they already speak passable English. They will, however, need some kind of employment services, and perhaps some short-term training, in order to get into the work-force. This language in the appropriation will enable service providers to work them into already-existing, refugee-serving programs simply as marginal add-ons; the small number involved, of whom only a portion would take advantage, would not overload the system.
