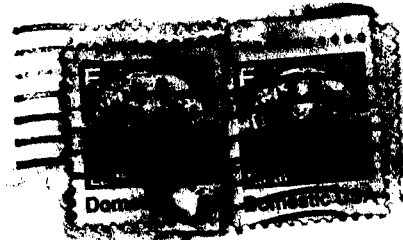

Lời đầu thư mình xin gửi lời chúc chị và gia đình được trăm ngày
sức khỏe, may mắn và vạm vỡ như ý.

Lần trước Bác Đề có bác mình viết thư đi nhờ chị, mình
viết vì ngại quá: chẳng nhớ thấy người sang bắt quăm làm họ.
Vội lại hiểu hai đứa mình học chung một lớp ở cuối giờ hành chính
mà có nói với nhau một câu nào đâu. Nhờ lại thời đó mình cảm
thấy hết sức bực tức - Bây giờ thì mình xin mao mui viết thư
này để trình bày rõ sự việc của mình. Chắc chị cũng thông cảm cho
vì chuyện con cái mình trong cảnh chia ly đất ruột này mà không rõ
lắm ngo. Xin chớ quên cảm ơn chị trước và bây giờ mình trình
bày về diễn biến hồ sơ của mình như: ngày 24/1/1985 hồ sơ mình
được chuyển lên Ng. Du và bắt đầu từ đó ngừng lưu. Đến nay
đang giải quyết ~ người đã có xuất cảnh như năm về trước, tuy vậy
vẫn có ~ hợp được cấp xuất cảnh trong diện ưu tiên ngoại giao.
Mình đã đến Ng. Du cả chục lần đi xin đồ tước I 171 và hồ sơ
hợp lệ nhậm. Mình có quen 1 gia đình ở thôn 11 xã và rồi người
ấy nói là gia đình bên đó nhờ một ông Thị Nghé sĩ viết thư cho Hà Nội
và Bangkok cam thiệp dùm.

Mình có liên hệ hỏi thăm biết được hướng giải quyết hiện nay là
Hà Nội sẽ lên danh sách ~ người có tội qua Bangkok rồi Bangkok
sẽ lọc lại rồi lên một danh sách khác rồi gửi về VN từ danh
sách đó. Việt Nam mới gọi lên để giải quyết. Đợt này có 17 hộ được
mời lên phỏng vấn rồi cấp xuất cảnh và cho đi luôn. Những hộ
này cũng thuộc diện can thiệp như mình đã nói ở trên - Vậy
chị xem nếu có thể được thì giúp mình là can thiệp với Hà
Nội và Bangkok để gia đình mình sớm được đoàn tụ cùng.
Cộng ơn này mình xin ghi nhận một đợt chị Minh Thoa.

Chị Minh Thoa gửi mến!

Hiện chị được mấy cháu rồi mình nghe nói chị có một cháu hiện
là bác sĩ tại VN và không chịu đi phải không? Có ăn học giỏi
như thế thì thật là hành diện nhỉ? mình thêm muốn con cái được
ngoa ngoảnh học hành giỏi như vậy lắm. Ồ! thế còn anh thì sao,
hỏi chị? đã sum họp nhau chưa hồi lâu rồi mình nghe nói anh sắp
đi rồi - Cặp thế mình xin gửi đến chị lời chúc tốt đẹp nhất và
một lần nữa xin cảm ơn chị nhiều, nhiều thật là nhiều.

như vô vọng về sự hái trái của Công sản...


