Fort Monroe and the area surrounding it has many places of interest. Perhaps you should consider taking a full vacation in the area to visit such places as colonial Williamsburg, Williamsburg Pottery Factory, Busch Gardens, Yorktown, Langley Air force Base (NASA), U.S. Army Transportation Museum, Mariners' Museum, and many, many more places of interest, all within one (1) hour or less from Fort Monroe. To Make it easy on the budget the hotel will permit early arrival and late departure at the same rate. Plan to stay all week. Many local restaurants are within walking distance of the hotel.

Bring your bathing suit so you can swim in salt water at the indoor pool. If you like to go ocean fishing bring your tackle with you as there are fishing piers at Fort Monroe where you can fish to your heart's content without a license. Tennis, shuffleboard and golf are available plus bicycle riding. Afterwards you can enjoy a refreshing sauna or jacuzzi.

The reunion will be held from September 20-23 1990 and lodging registration will be handled by each individual by means of a registration card that is enclosed. A special rate of \$45 plus tax, per night, single/double occupancy is available (included a free buffet breakfast each morning per person). Feel

free to call their toll free number. Use 1-800-446-1045 from Eastern U.S. and 1-800-582-8975 if calling from Virginia. Check in time is 3 P.M. and check out time is 12 noon.

Please note that reservations must be made by August 20, 1990. Those received after that date will be handled on a space available basis. The hotel fills up rapidly, so please make your reservations early so you will not be disappointed.

Two tours are being made available to you. Friday afternoon departing at 1:30 P.M. will be a tour of Norfolk where you will visit the MacArthur Memorial and also tour Norfolk Naval Base. Then, at the end of the tour, there will be a dinner at the Naval Base gallery at 5:30 P.M. Total cost will be \$22 per person/ On Saturday there will be a tour of Williamsburg and Yorktown from 9:00 A.M. to 4:00 P.M. A guide will be with you on both tours. You will hear a narration of America's earliest beginnings, walk in restored areas of Williamsburg, then drive to Yorktown via scenic Colonial Parkway. See the colonial villages before going to the battlefield where Cornwallis surrendered to George Washington in 1781. View film, see the redoubts and siege lines. Total price will be \$21.00.

The evening banquet will be at 6:00 P.M. on Saturday. The menu for this year's dinner will be choice of: 1.) Roast Prime Rib of Beef Au Jus, or 2.) Filet of Flounder, Bonne Femme. Both will have an appetizer, salad, vegetables, etc. The total cost for the dinner will be \$25.00 per person. ## THE FLAG

## Editorial

For quite sometime now the controversy has been raging over THE FLAG as to whether or not it should be protected by law. Most of my life I believed that THE FLAG was protected by law---I also thought that English was our official language--now at this late date I find that neither is true.

I have listened to all the arguments and have read the various opinions that have been available. I must admit that I sometimes wavered from my heartfelt belief that our FLAG should be protected by a constitutional amendment. However, the July issue of the American Legion magazine arrived and it contained a two page message written by their National Commander, Miles S. Epling. I would like to quote some of his reasons, heretofore unknown to me, for a constitutional amendment: "Some argue that to afford the U.S. Flag special status would somehow weaken our nation and threaten our rights. Granting special status for the Flag is no novel experiment. Congress has passed laws protecting other national landmarks and treasures. It's illegal to paint political messages on the Lincoln and Jefferson Memorials, and to deface the Tomb of the Unknown Soldier and the Washington Monument. It's even against the law to write political comments on the Supreme Court building, where the notion was born that flag-burning and political expression are the same.

The Commander goes on to say--"all of the 435 offices in the U.S. House of Representatives are up for election. Most House members will return to their home districts when Congress goes into recess in August. Every Legionnaire should make it a point to ask his representative where they stand on the amendment. Our congressman must take a stand for the flag or against it."

"While we work to protect our national banner, we must stay focused on those events more than two centuries ago that spawned the greatest experiment ever devised by man -- the establishment of the United States of America."

"I'm not ashamed to say that I love America and all that represents. I know how proud you are to carry the flag and to stand tall on behalf of all that it represents.

After reading these facts I no longer have any doubt in my mind that every one that has served our country should now rally around THE FLAG and demand a constitutional amendment! I urge every member of the Americal Division Veterans Association to take a stand on this issue and let his voice be heard. This is the year--many people are concerned about being elected or re-elected to Congress. If they can stall us past November they will stall for another two years. NOW IS THE TIME!

(Mitch really was the man who put in a tremendous amount of time and effort to give us such a great Reunion); Fred & Mary Hitzman (Asst.) for your help and support at all times; John (Dutch) & Janice DeGroot (Asst) for your hard work and enthusiasm and in particular for putting together the Souvenir Booklet; Brian & Mimi Mulcrone (Asst.) for your help and support at all times. The Committee met each month for about 11 months and worked extremely well together, (the beer was good too). Our compliments to the two Viet Nam Vets on our Committee, Dutch DeGroot and Brian Mulcrone. You guys were great and very refreshing with your thoughts and ideas. Keep it up and perhaps you can run a future Reunion.

Last but not least, we wish to thank the Americal Division Veterans Association National Officers for all of their help and encouragement; it made our job easier.

Howdy Guys;

Well Ron, here's the "sit rep" on the Americal colors I asked for. They arrived in good shape by the U.S. Post. They were returned to Boston by the U.S. Post. Here's where I want to stutter or stammer. I received the colors a little more than a week before the Houston parade & stand down. I had already made plans to walk with the Last Patrol from Cleveland, Texas to Houston, an easy walk about 12 clicks a day. On the first day we were about 4 clicks from our night laager when an 18 wheel truck ran over us. Our police escort who was about 100 yards behind us, with his lights on, took the blunt of the impact. The man did this, staying in place, knowing that that it would be his last act. The only people hurt bad were the people in the support trucks. All of us walkers were able to get out of the way because of the warning from Officer Earl McFarland. His wife had a baby a couple of weeks after the funeral. There is a trust fund set up in his name at the Cleveland 1st Bank & Trust P.O. Box 1789 Cleveland, Texas 77327. The Last Patrol is going to walk again in Officer McFarland's memory sometime in the fall. A note about the Last Patrol. We walk all over the country to call attention to all POW's from all wars. Can you believe there are POW's from WW2 that were taken from German camps and never returned by the Russians. There were over 300 listed POW's from Korea that were never returned. Now, North Korea wants to exchange POW's with us. At least they want to discuss it. Something is wrong. Meanwhile, back at the parade. The morning of the parade the Americal mustered up on a side street where we waited. I had the colors unfurled to mark the spot when I saw an Americal flag show up. Last year we had no colors, so one of the wives made one. She did a good job and was proud of it. I may get some flak from this but I took the colors you sent and walked with the Last Patrol at the rear of the parade. We joined back up at the park but I couldn't ask the lady to put that home made flag behind the colors. Sorry guys. Bottom line is that a good time was had by all, with no troubles.

## SOUTH VIETNAM

Dear Civilians, Friends, Draft Dodgers, Etc:

In the very near future the undersigned will once more be in your midst, dehydrated and demoralized, to take his place again as a human being with the known forms of freedom and justice for all; engage in life, liberty and the somewhat delayed pursuit of happiness. In making your joyous preparations to welcome him back into organized society you might take certain steps to make allowances for the crude environment which has been his miserable lot for the past twelve months. In other words he might be a little Asiatic from Vietnamescititis and Overseasitis, and should be handled with care. Don't be alarmed if he is infected with all forms of rare tropical diseases. A little time in the "Land of the Big PX" will cure this malady.

Therefore, show no alarm if he insists on carrying a weapon at the dinner table, looks around for his steel pot when offered a chair, or wakes you up in the middle of the night for guard duty. Keep cool when he pours gravy on his dessert at dinner or mixes peaches with his Seagrams VO. Pretend not to notice if he eats with his fingers instead of silverware and prefers C-rations to steak. Take it with a smile when he insists on digging up the garden to fill sandbags for the bunker he is building. Be tolerant when he takes his blanket and sheet off the bed and puts them on the floor to sleep on, and by no means try to wake him by saying "GOOOOOD MORNING VIETNAM".

Abstain from saying anything about Chu Lai Steak, powered eggs, dehydrated potatoes, fried rice, fresh milk, or ice cream. NOTE: The following is copy of a Citation and a Certificate that Harry Milne was awarded for his bravery under fire while on the island of Cebu. (Citation follows in next column)

## CERTIFICATE

16 April 1945

On the afternoon of 8 April 1945, I Company, 132 Infantry Regiment which I command, attacked and seized Hill Number 26, Cebu, Philippines Islands. Second Lieutenant Harry B. Milne, O-1183930, FA with a party of enlisted men, all from C Battery, 247th Field Artillery Battalion, was working with I Company as artillery forward observer, supporting the operation. The mission of I Company was to seize Hill Number 26 and hold it at all costs. The location of this Hill, representing the extreme end of a narrow salient extending three quarters of a mile into enemy held territory, made it a key position for the battalion attack on Hill number 25 scheduled for the following day. Hill Number 26 was the highest point of land in this vicinity and the upper part of the hill was bare except for grass and a few small bushes. As a result, our positions on this hill were exposed to enemy observation and fire from north, west, and south.

After seizing Hill Number 26, about 1600 hours, we were subjected to heavy enemy automatic fire from south and west, most of which was coming from 20 millimeter anti-aircraft type weapons firing explosive shells. The fire continued at intervals through the evening and night causing many casualties in the Company. At about 0300, 9 April 1945, the firing grew intense, at which time two infantrymen, about fifteen yards from Lieutenant Milne's foxhole, were wounded. With utter disregard for his personal safety, Lieutenant Milne left the comparative security of his fox hole and moved over exposed ground to their aid. While doing so, Lieutenant Milne was critically wounded. Earlier in the evening two of Lieutenant Milne's men had been wounded by enemy fire. I Company's total casualties for the night were twenty four. While serving as forward observer with I Company, Lieutenant Milne did outstanding work in aggressively bringing down artillery fire on a number of positions in the path of our advance.

That is how the Chinese and expatriates manage their business affairs. They even continue to work at home evenings. They do not count time. Their aim is to get things done, not half done. Why not Solomon Islands businessmen do the same?

Solomon Islanders running small businesses have created in their bloodstreams a new disease which will greatly affect their business ventures. The disease is the tendency to leave the work to be carried out by others while owners are either in a bar, discuss politics or have coffee at an unknown restaurant.

As soon as money starts to come in, owners also start to leave their job to do other things. You cannot run a business by remote control. It will not work. The result will be a quick climb and a sudden fall. The aim is to stay afloat as long as you can. There is no need to blame the expatriates or government for our failures.
