178th Assault Support Hel. Co.

Dear Americal Division Veterans Association:

I know that at times the 178th Assault Support Helicopter Company "Box Cars" came under 1st Aviation Brigade. I know that they were several periods in which we came directly under Americal Division. But the bottom line is that we nearly always directly supported Americal Division and were the only "heavy" support until the 132nd ASHO moved into Chu Lai in June of 1968. At different times I was told to wear the 1st Brigade Patch and the Americal Patch. My old field jacket still has Americal on the right shoulder and 1st Bde. on the left. Confusing? It sure was to me. Guess that's why my old field jacket still has both patches on it. Anyway, I was the guy that scheduled mission for Tony Percoskie and Dan Shoplock and, sometimes when they were real hard up for gunners, they would let me ride the gun. After Nam I went back to my airline job with Braniff International Airways in air operations at O'Hare Field in Chicago. About 1980 things were getting pretty shaky at the old airline and someone said the Air Force Reserve was looking for vets. They gave me a deal I couldn't refuse, Staff Sergeant with a one year trial enlistment! It turned out to be a good decision because in May of 1982, Braniff died suddenly, along with it my airline career. The Air Force then took me on as a full time reservist (Air Reserve Technician with a mandatory military commitment) and here I am, back with the military! This time I'm going to hang around for retirement. Just finished my second war in the military (but hoping they won't have any more til I retire) and I must say, they did it Right this time! Of course, that's because Americal Officers (and other Vietnam vets) ran it this time and were determined to do it right. Now I'm really glad I was in the military for the Gulf War, the support was outstanding this time (and still is)! At this time we are still on 24 hours here in the Command Post, mainly to make sure that our medical people still over there (helping the Kurds & Iraqi refugees) get all the support they need (we patch through calls to family and friends and many other services) and when anyone returns (as a group or individual) they are always met by a welcoming committee of friends, relatives and officials, both civilian and military - AND THIS TIME THERE ARE NO JEERS AND NO ONE GETS SPIT ON! NO JANE FONDAS AND DEMONSTRATORS! JUST A LOT OF YELLOW RIBBONS AND CHEERS OF JOY! Sure wish it had been that way for us after Nam, but I am real happy for these people and PROUD to be serving again.

I know that I enclosed more documents than you requested, but you might find them interesting. No need to return any of them. They are all copies. It's interesting how the size of the orders has changed. I couldn't get the copier here to double side the old orders because of the size difference.

I have an old friend who was in the 198 Lt. Inf. Bde., I'll have to ask if he is a member. Also, I have lots of maps, charts, notes, ect. from Nam. Maybe someone will be interested.

CHAPLAIN'S SECTION CHU LAI

While at the Chicago parade on May 10th., Americal MP Brian Mulcrone was fortunate to meet up with SGM Will Rogers, who was a staff chaplain with Task Force Oregon. He promised Brian some follow up articles on the chaplains section in Chu Lai. The following is a letter from SGM Rogers that will bring back some memories of the old division camp at Chu Lai.

Dear Mr. Mulcrone;

I am enclosing a copy of orders dated 9 April 1967 sending me TDY to "Project Oregon" for 90 days. I stayed beyond that until it was activated into the Americal Division. Chaplain (LTC) Burton Hatch, Chaplain (Major) Edward Flatley, myself, SP/4 Terry Covington and one other chaplain assistant comprised the original chaplain section. I have forgotten the last name of the other assistant, but his first name was John. I left Bien Hoi for Saigon and then on a Japanese LST with our vehicle, trailer and all the office equipment for Chu Lai. I met the others of the staff when I arrived. Me, Covington and the other assistant, John, started the section. Chaplain Hatch and Chaplain Flatley came in a few days later on a chopper. Our location was on the corner. We were the first section as you came on the compound. The chapel was right across from our office. There was a dental clinic, I think, just in front of us, staffed with Navy personnel. Chaplain (Major) Tony Wilderding followed Chaplain Flatley as assistant chaplain. Chaplain (Captain) James Rogers, DISCOM Chaplain was located next door and conducted some of the worship services in the chapel. It was relatively quiet during our tenure there. About a month after I departed Command, the hooch I lived in was destroyed in a rocket attack. The Division came into being just before I PCSed. The activation ceremony was attended by General Westmoreland. The time frame, I believe, was October 1967. I hope this short overview fills in some areas.

AWARD OF THE SILVER STAR

GEORGE, PHILLIP A. RA 18 959 118 PFC E3 U.S. Army, Company B, 39th Engineer Bn, (Combat) APO 96374
Awarded: Silver Star
Date Action: 12 August 1967
Theater: Republic of Vietnam
For gallantry in action against a hostile force in the Republic of Vietnam. PFC George distinguished himself by heroic action on 12 August 1967 when elements of B Company, 39th Engineer Bn. came under heavy sniper fire during an opening and clearing operation along Robertson Road which delayed progress for four hours. Whenever the engineer vehicles started to move, sniper fire from undetected positions in the nearby marsh and hill would force the drivers to jump for cover. It soon became obvious that unless the road was finished and the convoy moved on through, the work party would be vulnerable to attack when darkness fell. Although fully aware of the danger involved, PFC George volunteered to complete the work on the road with his bulldozer. He refused to jump for cover even though sniper rounds were ricocheting off his machine. In spite of the fact that he was completely exposed to enemy fire, PFC George courageously remained at the controls of his bulldozer and finished clearing the road. When the engineer convoy started through, the third vehicle was hit by enemy fire and run partly off the road. It could not be moved and blocked the escape of all vehicles behind it. The snipers began to concentrate their fire on the blocked vehicles. A call went out to PFC George who by this time had reached a secure area about a mile down the road. He unhesitatingly turned his bulldozer around and drove back to the vehicle, under sniper fire all the way. PFC George hooked onto the vehicle and pulled it through the rice paddies, still under enemy fire. Due to his outstanding courage and coolness under fire, the engineer element was saved from the possibility of a Viet Cong attack. PFC George's valor, selfless devotion to duty and willingness to risk his own life to save those of his comrades are in the highest traditions of the military service and reflect great credit upon himself, the Americal Division and the United States Army.

Editors note: Thanks to ace demo-man and tunnel rat Maurice Henson 196th LIB, for sending us this award citation. We'd enjoy printing some others if they are received at the newsletter.

Through the years since, while building my career and family, I have moved around a lot, searching for work where the men displayed the courage, drive and commitment I found in a rifle company. I'm sure you and many others looked for the same thing, and you already know what I found: Nothing. And, after twenty years, I realize I'm not going to find it. That was a very special world that doesn't exist anymore, except in my memories and those of my comrades in arms.

When I received my first copy of the Association newsletter, I couldn't put it down. For the hour it took to read it, I was back in the bush with all the brave men I admire so much. Please keep the newsletter coming, and if there 's a chapter somewhere near eastern Nebraska I'd like to get in touch. I'd also like to get in touch with two good friends, Mike Williams and Keith Rasmussen. Keith was from somewhere in the Dakotas, and Mike was planning to settle down in San Francisco, when I heard last in 1972. If they're Association members, would you please pass the word for me?

VIETNAM-STYLE

What's it all about? Last week this reporter found out what the war's all about. The big issue in Viet-nam's bush-country isn't imperialism, Asian economics, or the question of relocation of the masses.

The big issue here in the Valley of the Happiness River is the welfare of a small montagnard boy. Just before noon one day, a montagnard woman, aged beyond he 30 years, appeared at the gate of the Civilian Irregular Defense Group (CIDG) Camp at Minh Long. She asked to se "bas-si"-the doctor.

Slung over her shoulder according to the fashion of the Hre tribe was an emanciated looking, small boy, less than two years old.

The woman was led to the dispensary by one of the local tribesmen serving the CIDG's here and introduced to the "bas-si", SP4 Clifford H. Brenner (Harlington, TX) the Special Forces A-Team medic.

Brenner, a graduate of the Army's 48-week course at Fort Sam Houston, TX, speaks none of the montagnard dialect, and the woman could speak no English. In fact, her knowledge of Vietnamese was extremely limited, for like most montagnards she had never learned the language of the Viets.

To make her needs understood, she unwrapped the child from the dirty black-cloth sling and pointed to the boy's feet. More than a dozen sores were spread over the area from the ankles to the toes.

She explained, using many hand signs and broken Vietnamese, that when the boy complained of pain, "she took all of the known Hre measures". She had taken him to the village shaman, or witch doctor, who advised the sacrifice of a chicken whose blood would be spread on a pole in front of her house and the feathers burnt.

When this failed to cure the boy, the illiterate, comparatively primitive woman, carried her child more than nine kilometers through bush country and dense jungle to find a "Hoa Ky" (American) medic to get aid for her son.

This woman, a primitive from another century, knew what the local Viet Cong cadre might do when they found out where she went for help.

Now, here was a woman whose husband, father, brothers, or maybe even herself, had fought against the "Hoa Ky" soldiers in the hills. But she was also a mother. A mother who despite the pettiness of local politics and Picayune ethnic prejudices, brought her child to a small way station in the jungle--thinking first of her son's health and his future.

And that's what war is all about.

27 Aug At 1325 completed combat loading having received 2,209 tons aboard. Took on board 8 Army LCM'S.

30 Aug Cebu Harbor, Cebu. At 1420 embarked a total of 8 Officers and 138 Men of the Americal Division for transportation.

1 Sept At 0945 took departure of Cebu enroute SAGAMI WAN HONSHU.

8 Sept At 1231 moored starboard side Pier "A" YOKOHAMA, HONSHU. At 1319 commenced unloading Americal Division.

9 Sept at 2100 completed unloading.

10 Sept At 0655 disembarked all personnel of the Americal Division.
