JESSE R. DROWLEY SCHOLARSHIP

The Muehrcke Foundation, set up by the family of Dr. Robert C. Muehrcke, who served with the 132 Infantry during World War II, has set up a scholarship in the name of Jesse R. Drowley, the only man in the Americal during World War II to be awarded the Medal of Honor.

The details of this scholarship will be carried in the September - October issue of the Americal Newsletter.

Dr. Muehrcke has been most active in perpetuating the history and deeds of the Americal Division. He was the driving force in causing the Guadalcanal Memorial to be built.

He has given most generously of his time and his resources to honor the name of the Americal.

FELLOW AMERICAL VETERANS

A group of your fellow veterans have been exchanging experiences about their time in the military and their present lives. This group has been using their personal computers to communicate with other veterans on a daily basis using National Bulletin Board service. We have found one that offers the nationwide coverage we need 24 hours a day with unlimited bulletin board service for only \$5.95 per month, which also includes 60 E-mail messages. That service is National Videotex, or NVN for short. To join up, you only a IBM compatible or Apple Macintosh computer with a modem and a communications software package. To sign up call 1-800-336-9096. This service has been tested and is judged "Veteran friendly". Because of our recent interest in NVN and the 115 Americal vets that have signed on when we started with Prodigy, NVN has given us our own bulletin board called Americal Division. Get on the wagon and join us. We have weekly chat sessions plus every day exchanges. Also you might find a lost buddy.

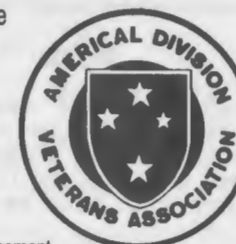

GUADALCANAL VETERANS

I have been intending to write ever since our trip to Guadalcanal last August. The trip compounded my already poor health, but I enjoyed every minute and have no regrets. After our return home, I suffered another heart attack (my third), some additional health problems, and eventually completed cardiac rehab. All this took time but I am finally on my feet and trying to fulfill a vow I made while in the Solomons.

I went to the remote village of Naiore'ore where the women still carry water for the village two miles up a steep hill. The village is primitive with no means of raising the government-required third of the cost of a water pumping facility which the villagers have been trying to secure for some time.

I have been corresponding with agencies all the way from The Speaker of the Legislative Assembly in Western Australia, the Australian High Commission in Honiara, down to the village secretary in Naiore'ore. if the village can furnish one-third of the cost, the Australian High Commission in Honiara will proceed with the project and bear the remainder of the cost, as is customary for projects of this kind. In order to keep the cost low, the villagers will be doing most of the labor under the supervision of the Commission.

I committed to Morris Arahonosia, Secretary of the Village Council, that I would do my best to raise the village portion which comes to approximately \$2000 American. My fondest hope would be to find twenty people who would contribute \$100 each. However, I realize this may be unrealistic so we will gladly accept any amount, large or small. If more than \$2000 SHOULD come in, we will pro-rate the excess and refund to each contributor. Some of us on the trip used Morris as our guide, thus some of you will know to whom I made my promise.

Unfortunately, I failed to get many addresses that I wanted to, due to becoming ill while in Honiara. If you have addresses of some who made the trip perhaps you will be kind enough to send them to me. This would aid our effort greatly. I have only about a dozen at this time.

We have made application to the IRS to operate as a "not-for-profit" organization so that contributions will be tax deductible. The names of the organization is simply "Naiore'ore Village Water Fund", and we have opened an account at a local bank in that name. Checks should be made payable to this fund.

I sincerely hope you will want to be part of this project. We certainly will keep you appraised of progress, as well as the final outcome. I look forward to hearing from you. If If you have any questions write or call;

HELP HOSPITALIZED VETERANS

U.S.A.T. ARGENTINA

U.S.N.T. Argentina, a large ship, served both as a troop transport and a command ship for CU-37, NYPOE to the UK, Utah Beach and Cherbourg, France destination, August 27 - September 7, 1944. It is believed that CU-37 was the first convoy after D Day to move troops directly from the United States to France.

On this crossing the Argentina carried 246 Officers, 20 Warrant Officers and 4241 Enlisted men of the 26 (Yankee) Infantry Division.

The ship, previously named the Pennsylvania, was built by the Newport News Shipbuilding and Dry Dock Company Newport News, VA in 1929.

On December 17, 1939, while on a South American luxury cruise, the passengers of the Argentina saw the just-scuttled German pocket battleship GRAF SPEE in Montevideo harbor. A British squadron had been posted outside the harbor to do battle with the crippled German ship if she tried to escape. Trapped, the crew of the Graf Spee abandoned her to fire and explosion.

From early 1942 through January 1, 1946 U.S.A.T. Argentina made many troop carrying assignments including to Australia and New Caledonia, (that was us). Calls to Southampton, Oran, Gibraltar, Freetown and Durban were made. Add Sicily, Naples, Marseille, LeHarve, Taranto, New York, Boston and Baltimore to the list.

After the Argentina arrived in New York on New Year's Day 1946, she was converted to yet another kind of service to war brides and dependants. In 1947 the Argentina was again converted to a luxury passenger carrier and returned to the South America travel lanes. The ship was laid up in 1960. Does anyone know the details of the final days of ARGENTINA of CU-37?

On Christmas night, 1992, ABC-TV's 20/20 program reviewed several British bride's reunion. There in grainy old black and white newsreel footage was our old friend U.S.A.T. ARGENTINA embarking an early 1946 group of war brides and dependants at Southampton for passage to the United States.

We expected 250 at least, but wound up with a disappointing 109 who came, but who really had a great time. We renewed old ties and strengthened new friendships. God truly showed us his love by giving us warm, cool days and nights, free from tornadoes or severe thunderstorms Kansas is known for in June and July. I believe God must have spread his arms and thundered to the heavens 'let no rains fall, no heat penetrate, and to all who have come - have fun!'... Fun is what we had, despite the shell shocked manner in which the reunion chairman wobbled about, trying to keep order, and answer hundreds of questions from attendees. Newly elected Line Officers and Executive Board Members were installed by PNC Joe Chin. John "Dutch" Degroot is the new National Commander, Bill Maddox, Senior Vice Commander, Steve Dennison, Junior Vice Commander [absent], and Bernie Chase as appointed Adjutant and elected Finance Officer. All were warmly applauded as they took their offices.

At the meeting the future of the Museum was discussed and plans presented by Bernie Chase for a home in Massachusetts. No action taken on the report, as the current location is secure until approximately 1995.

The Muehrcke Family Foundation presented the Association a \$14,000 college tuition scholarship divided in \$3,500 a year increments for a full four years, to the child of a disabled Americal veteran. \$500 was presented to the Scholarship Fund from the 100 present reunion participants from a portion of their registration fees. An additional \$400 was presented from a raffle of \$1.00 tickets, which the prize of \$100 was won by a VFW member in a Mt. Prospect post, sold by Dutch Degroot. Other subjects presented and discussed were acted upon in prompt order.

On Saturday night at the main banquet, Mayor Harry "Butch" Felker of Topeka brought the greetings to the reunion of the city of Topeka, and made a few brief remarks. After the Mayor, General Ramsey spoke on the subject "Homosexuals in the U.S. Military" and addressed the cares and concerns regarding that problem, if implemented. Outgoing President Pete Messina presented the general with a copy of the book "Under The Southern Cross" and a pen and pencil set as reminders of his visit to the reunion. VIETNAM VET RECEIVES C.I.B.

After 20 years, CW02 Robert E. Gibney said he began to wonder if he had ever been in and fought in Vietnam. The student in the Intelligence Center's Warrant Officer Transition Course had been denied the award of the Combat Infantryman Badge since his return from his first tour in Vietnam in November 1970. Gibney finally received the long-awaited CIB recently when he graduated from his class at Fort Huachuca. Besides completing the class as the Distinguished Graduate, he had another pleasant surprise: the CIB. The highly coveted award was presented to him by Colonel Thomas Finnegan, the Information Systems Command's deputy chief of staff for personnel and a fellow veteran of the Americal Division in Vietnam. Finnegan praised Gibney for his actions resulting in the CIB. "It's good to see somebody get what he deserved a long time ago," he said. The CIB is awarded to infantry soldiers "for satisfactory performance of infantry duties in ground combat," as his award orders said. Gibney received his CIB for his actions during Operation Frederick Hill. This operation was a large-scale search and destroy mission conducted by the Americal Division north of Chu Lai in the Tam Ky area of South Vietnam in late 1969 and early 1970. The unit received from, and inflicted heavy casualties on the enemy. This heavy fighting was partially the reason for the late award of the badge. His unit's headquarters was overrun and records were lost during the action. Gibney said his unit was "practically annihilated." Upon returning to the United States, he did not think much about the badge until 1975, when he entered the Reserve Officers Training Corps. A review of his records failed to show any mention of the CIB. At the time personnel officials told him that as an 11D-series infantry scout, he was not eligible for the award. He was told that only 11B-series infantry could receive it, not the entire 11-series career management field. With that answer, he let the matter drop.

Last year while listening to some Desert Storm veterans speak of their experience, he started thinking of it again. Gibney called the military records center in St. Louis, where he was informed they had never heard of the Americal Division and that they had no proof that he was in Vietnam. Once again, he became frustrated and decided to drop the matter.

He credits his wife for seeing through his award of the CIB.

Susan Gibney, a personnel staff sergeant in the Army Reserve, did not want to let it go this time. Keeping her

efforts secret from her husband, she began to make phone calls, beginning with two congressional inquiries last July. She made a call to the Department of the Army Awards and Decorations Branch and was told her husband met the criteria, but they had no proof he was ever in combat. She eventually contacted Steve Echard, chief of Personnel Processing Services for the Intelligence Center. Echard, himself an Americal Division veteran, did some research and found out that the Awards Branch would accept two eyewitness accounts of Gibney's combat service. Echard contacted several veteran location services who provided Susan with unit rosters from the correct time period. She picked out soldiers from her husband's unit, A Troop, 1st Battalion, 1st Cavalry, and began to call. "I had a really hard time explaining to my husband what the big phone bill was for", she said. "I told him I was renewing contact with old friends from before we went to Germany".

She located two of her husband's friends from Vietnam, who were more than willing to provide statements for him. They specifically remembered him from Operation Frederick Hill. They submitted the statements and other supporting documents, but more delays occurred. With his graduation day approaching, Susan enlisted the help of the chief of Awards Branch, who had the orders verified, issued and faxed to Fort Huachuca, at 6:30 p.m., the night before the ceremony.

The award came as a total surprise said the graduate, who reiterated that he had begun to have doubts about his participation in Southeast Asia. He said that the joy in receiving an honor that he had gone through so much to get was tempered by the memories of his days there. He said that good things you remember from combat service begin to outweigh the memories of friends left behind and poor reception upon returning to the United States; however, the realities of combat are never far away.

But, he said he "...wouldn't trade the experience of Vietnam for anything".

My name is Ray Fawkes. I would like to know if anyone remembers an incident that happened about Feb or Mar 1971 at LZ "Fat City"!

I was assigned to a ground surveillance radar team. I was the SP4 in-charge. I had 1 week training in Long Binh with the rest of the team. Some Ranger Team was going out that night, I think on an ambush patrol.

There were 3 of us in my team, and we would run 4 hour shifts.

About 3:00 a.m., one of my team members woke me up and said the "Rangers were being over run"!

I called an Arty unit of 105's for support. I have forgot the unit. The Arty was asked to fire illumination on the Rangers position at their request, but the Arty battery commander said "no"!

Things were really confused. Cobra Helicopters were "shooting the place up"! After some bickering to Arty, they finally fired some illumination rounds. We later inspected the area and found the VC removed the little parachutes from the flares, and we thought probably for bandages. At the time this happened, I was TDY to Div Arty from A Btry, 1/82nd Arty.

Dear Sirs. I served in Vietnam from August 1968 to May 1969 with C/1/52, 198th LIB and worked out of Chu Lai. I was wounded several times with hand grenades, mortar, and 122 rocket shrapnel. I am trying to find someone who remembers me from my old unit, and what happened to me while in it, in order to establish evidence for a VA claim. Since I lost my memory in the last event in May 1969. While in the Hospital at Chu Lai, 1SG Sampson, a Colonel, and a Specialist from my unit came to see me at the 312th Evacuation Hospital in Chu Lai. It was the last contact with my unit I had before being sent home. My field name was "Smoke Bringer" and my real name is Howard G. Henderson. I finally located my medical records after 23 years trying, but have never received my Purple Hearts or other Awards I was supposed to get according to my DD Form 214 Report of Separation. The VA can't do anything for me without records. If anyone can remember me, please help me. This has been a tough fight.

Howdy Dave: This is "Mac" from Texas. Hope this finds you all fine and well, up there in Kansas. I made a couple of runs to Winfield, Kansas, back in 70, 71, & 72. Then in 73 to Hutchinson, Kansas. I am a motorcycle buff, and like to attend "meets".

Anyway, what I wanted to know is, do you know anything I need to know about this Agent Orange Veterans Claim. Any "ins" or "outs" that would improve my chances of a positive claim. I have not received my Agent Orange Kit yet, so I thought I would drop you a line and see if you had any luck. Like you, I am disabled, not the war, but from an on the job injury. I get a small pension, and that's all I got. I could really use the \$12,500 that is just sitting there with my name written all over it. I served with B-1-6 Inf, 198th LIB 1968-1969 in the 81mm Mortar Platoon. I was all over I Corps. I can remember C-130's spraying the Agent Orange S--- everywhere! Sometimes we were informed, other times we were not. Orders were to stay close to the tree line and out of direct contact with the stuff. We rotated to Hill 270 near Chu Lai and could see C-130's spraying Hills 1362 and 707. I never heard the word: "Agent Orange" until I got home. We always were told it was a: "defoliate". I'm sure I spent enough time in the bush to have either breathed it or come in contact with it. I'd like to hear. "Keep your wheels spinning and the beavers grinning!"

Ed note: Dear Bill. You bet. My claim was approved April 22, 1993 for a yearly benefit once a year until the program ended in Dec 1994. I was told I could appeal for back payments, and have done just that. I got my first check \$1493.33 last month. I have another due in April 1994 same amount. If my appeal is approved, I'll get all back benefits. They won't pay out \$12,500 in a lump payment. I hope and wish every Vietnam vet would apply to The Agent Orange Veteran Payment Program. [REDACTED], Hartford, CT 06104, Tel: [REDACTED] and make application. The forms are easy to fill out, and that's all it takes is 30 minutes of your time, an envelope and postage stamp. Your physician fills out a small form, and

that's it. It takes about 90 days to get answer. The Americal Division, stationed in I Corps, all the years it was, 1968 to 1972 was dosed by Agent Orange on a regular schedule and the body can come in contact with it many ways and become infected. You owe it to yourself guys, and Bill, to make an application for benefits. The government won't tell you to, but - you have that right. You fought for it, and deserve it.

This is Memorial Day - I have watched some of the difficult memorial programs on TV and they brought back many memories. A few weeks ago, my Wife brought something I did not even know I had, which she received while I was in Vietnam. I was First Sergeant of B/20th Inf, 11th LIB, 68-69. I was on a combat sweep with the 3rd platoon on March 3, 1969. There was 24 of us on the sweep. It was about noon time when we were ambushed by a 130 man company of NVA Regulars. They were fully equipped. We killed about 30 of them, and we lost 5 killed and 8 of us wounded. In that battle, two men of my unit were awarded the nations

highest decorations. SGT Lester R. Stone, a Squad Leader was awarded the Congressional Medal of Honor, and SP4 Dean Moering, a Squad Leader was awarded the Distinguished Service Cross, while assisting me as I lay wounded. These two men were so young, and I an old man at 38. These brave men will live forever in my memories.

As President Clinton walked down the pathway at the Memorial Wall, I thought to myself, "Mr. President, those names on the wall cannot talk back to you as those of us who served and saw the life blood of those young men gave for their country". David, I let a little out today, I am sure you understand the feelings.

A DESIRE TO SERVE

Across the United States today, in Veterans Hospitals are our aged brothers of wars past afflicted with all kinds of medical problems that need help of those of us who can give of our time to help them establish claims for war injuries they received in battle. Many frustrated with insufficient evidence or expertise to help them establish how and where they were injured in battle, who witnessed the injury, and under what conditions was the injury received, simply turn away from pursuing their claims, unable to afford the costs involved to fight a system that seems to have no other mission but frustrate and foul up applications for compensation from eligible veterans for injuries received in battle. Some medical conditions take years to surface, and long after the battle has ceased, memories have faded, and the principals involved have split to the four winds, a veteran suddenly comes up with a medical condition he did not know he incurred while in battle. Such is the infection of our bodies with the horrible effects of the forced radiation treatments inflicted on soldiers in the early 1950's by our government who threatened soldiers with harsh punishment if they talked, or those who served in places where atomic radiation effects were present like on Bikini Island in the South Pacific, or in Hiroshima or Nagasaki, Japan. Some of our guys still live who were infected with the dreaded mustard gas of World War I in France. Of more recent infection by horrible effects on veterans is the dreaded Agent Orange chemical bombardment of Southeast Asia against the communist hordes that lived in the jungles waging a war against their countrymen and where U.S. troops were sent to fight the Viet-Cong in Vietnam, in Laos, Cambodia, and other invisible areas where war was not known to be being made. High flying aircraft such as C-130's, especially equipped with chemical defoliant agents spraying capabilities, regularly flew over the heads of U.S. and ARVIN troops and a local civilian population, dropping and spraying chemicals to wipe away the hiding place of the enemy so he could be destroyed. It has all come full circle. Veterans are showing those effects today, long after the battle has been waged or experiments terminated and records lost and witnesses gone to the four directions of the wind.

It has been my crusade since becoming Vietnam Editor to keep before Americal veterans of World War II and Vietnam to never give up in their attempts to claim their injuries received while in combat from battle injuries and later the after effects of Agent Orange and its cancer causing agents. I will never let up, and I will keep encouraging my fellow veterans to make application to the Veterans Administration claims for compensation, and asking those veterans who remember incidents involving their comrades in battle, to come forward and support a brother with statements to verify the fact they witnessed the incident being claimed. It's my belief that such a person would want someone to witness for them if need be, in a similar manner.

Because of this commitment, I have made application to the State of Kansas to become a Service Representative of the American Legion here in Kansas, to be considered for hiring on a full time basis to assist Kansas veterans in making application for VA benefits. I don't know how this quest will turn out, but - I'm willing to do it for free if I could become certified. I am asking you Vietnam vets who still are of working age to seek information from your own local American Legion, Veterans of Foreign Wars, or Disabled American Veterans posts, and apply for open positions in this work, and to get certified as a claims service representative, and assist those brothers of ours who stand confused, afraid, and alone, in a world of complicated paperwork dumped upon them by the government to prove their claims in order to be considered for compensation. I'm also asking you individual Americal Division veterans of World War II and of Vietnam to write to your Senators and Representatives in Washington, D.C. and ask them to pass legislation to allow Veterans to be recognized by the Veterans Court of Appeals where their cases can be reviewed without horrendous costs assessed

by that court and Department of Veterans Affairs. You, might recall, I printed an article on that fact in a previous newsletter and our National Commander wrote a letter to his State Representative, and we printed his reply.

I asked individual members write their congressmen and Senators, and to please send me a copy of the letter. I have yet to receive one single letter from anyone in support of this crusade, and it leaves me wondering "why"?

I would like to again ask all of you Americal veterans to please take the time to write such a letter to your congressman and senator and to ask them to introduce and support legislation to lift the non-recognition ban on veterans to the court of appeals of the veterans administration so complicated claims can be received and acted upon by that court without a tremendous personal expense. It's my belief that a veterans constitutional right to justice has been infringed upon by congress and that it is a wrong that must be righted.

We are really, "our brothers keepers" and I know that each of you, if the need arose, would welcome some veterans coming forward to help you establish a claim.

Don't give up. I am an example that something can be done, if one will but be persistent in their quest. Truth cannot be denied, and truth will crumble any wall or barrier.

Please give this suggestion your consideration, and act accordingly.
