COMPTEMDIRDET proceed and report CINCPACFLT, Pearl Harbor, Hawaii, TEMDIFOT about two days. COMPTEMDIRDET proceed and report COMFAIRWESTPAC, NAS, Atsugi, Japan, TEMDIFOT about two days. COMPTEMDIRDET proceed and report COMNAVSUPPACT Saigon, RVN, TEMDIFOT about two days. COMPTEMDIRDET proceed Binh Thuy, RVN, arrival report immediate superior in command if present, otherwise by message, DIFOT as CO, HELATKRON Light Three.

Provided no excess leave involved, authorized to delay in reporting, to count as leave, NLT 18 January 1971 and NET 17 January 1971, Little Creek, Norfolk, Va.; NLT 4 February 1971, Fort Rucker; 8 March 1971, Vallejo; 15 March 1971, San Diego; 18 March 1971, Pearl Harbor; 22 March 1971, Atsugi; 26 March 1971, Saigon and 31 March 1971, Binh Thuy.

Travel via government transportation authorized outside CONUS. While traveling via Government air outside CONUS class TWO priority certified.

Command delivering orders comply current BUPERSINST 4650.14.
