Dear Don;

I /we would be most appreciative of any further history you may be able to come up with concerning this "Huey" who we have named 'Lady Belle'. A professional songwriting couple has even written a song about her which I will try to get a copy of and mail off with the rest of this stuff.

I would be most interested in having the 'Official' detailed history of Seawolves. It would certainly be something to add to the histories of 'Lady Belle', and the other units that she served with. Enclosed is a detailed history from '63 to '76 and yes she was at Corpus Christi, twice.
