From the Treasurer...

As many of you know and quite a few have questioned, the initial Reunion 2000 registration form was a disaster. I am sure that it has caused many of you to rethink your desire to attend.

First, through my bungling incompetence, I inadvertently indicated that late registration was effective 1 March when I intended it to be 1 May.

Second, I made it grossly unclear as to whom the registration fees applied. It was originally intended that everyone who attended should pay the full fee of \$35.00 per person, with children under 12 paying a reduced amount. The reasoning behind this decision was based on helping the Association recoup some of the losses from the 1998 Jacksonville reunion as well as providing additional activities and services at this reunion. This included our running our own bar, more door prizes, sodas and snacks for the children, etc.

As a result of these two items and the number of complaints/comments that the reunion committee has received, we are revising the fee structure as follows:

1. *Association members pay \$35.00 whether they attend the entire reunion or only a portion thereof.*
2. *The fee for adult guests of Association members is \$15.00 with the same guidelines as above.*
3. *The fee for child guests of reunion attendees is \$5.00.*
4. *The late registration fee is waived, however I still encourage members to register as early as possible so that we may ensure accurate meal and tour counts.*

For those of you who have already paid, I will be adjusting your account to reflect these new charges and be issuing a credit memo indicating the amount to be credited to your account. Some of you will elect to take a refund, some to apply all or part to merchandise or next year's dues, and some may elect to donate the balance to the Educational Assistance Fund. Whatever your choice, I shall endeavor to process the paperwork rapidly.

If you are unsure whether or not you will be able to attend, register anyway. You may cancel at any time, without penalty, up through 1 June.

My sincerest apologies for all of the confusion that this may have caused.

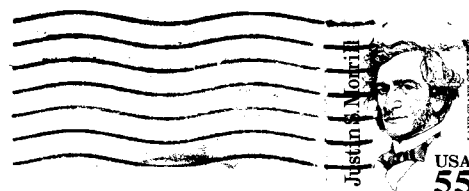
