

ORDERS FOR THE GATE #4 SECURITY GUARDS

1. Do not allow personnel or vehicles to congregate inside or outside the gate in the vicinity of guard shack.
2. The only U.S. Army enlisted personnel allowed to utilize Gate 4 are those who are on official business, i.e., "Dustoff" and "Castle". Those U.S. Army personnel so authorized will have a pass signed by their unit commander. U.S. Officers are not required to possess a pass.
3. Republic of Vietnam Armed Forces enlisted personnel other than Navy, must have a USN escort or a valid identification card or pass signed by a CFAD Binh Thuy command to be allowed access to Navy Binh Thuy (CFAD area).
4. Ensure that all personnel entering or leaving the base are inspected. Ensure that all bags, boxes or other items are closely checked. A property pass must accompany rationed articles in order to remove them from the base.
5. Supervise the Vietnamese Gate Guards to ensure that they are properly performing their duties. Make certain that a complete inspection is given to all Vietnamese personnel entering or leaving the base. Report any discrepancy concerning the Vietnamese Guards to the FASU Duty Officer immediately.
6. Ensure that U.S. military personnel entering the base after curfew are logged in and are reported to the duty officer of their respective command.
7. Report any disturbance to the FASU Duty Officer.
8. Do not allow any personnel off the base during curfew unless they are on official business.
9. Check incoming vehicles as feasible for possible hidden booby traps, contraband etc. Check all departing vehicles, including FA&E and RMK trucks, for unauthorized cargo.
10. Military personnel in civilian clothes are not authorized to drive government vehicles off the base unless they are attending an official function which specifies the wearing thereof. Questionable cases will be referred to individual commands for resolution.
11. Do not allow Vietnamese civilians without a base access pass to enter without prior approval and then, only if properly escorted. Trash trucks will be escorted by a U.S. Guard at all times while on base.
12. Do not allow vehicles to block the gate.

13. Have your weapons ready and know how to use them. Keep a full clip in the weapon but do not put a shell in the chamber unless you are required to fire the weapon. Ensure that the weapons are properly accounted for and turned over to relieving watch personnel.
14. Be in the complete uniform at all times (blue USN dungarees are not authorized).
15. The gate guard will render the proper military and civilian courtesies to all personnel passing through the gate.
16. Check field telephone communications with FASU Duty Office at 0800 daily.
17. When base is under Yellow Alert Gate 4 will remain closed except for passage of official traffic.

GUEST REGULATIONS

1. Personal female guests are normally authorized aboard the base during the following hours only:

Monday through Friday 1200-2200
Saturday & Sunday 1000-2200

2. Female guests are not authorized in living quarters, barracks or work areas.

3. Female guests are authorized to visit the following places: various clubs, the movie theater, and approved picnic or show areas. They will be escorted directly to and from those areas utilizing roads only.

4. Female guests will be escorted by their sponsor at all times and will at no time be left unattended. Sponsors are responsible for guests while they are on board the base.

5. Only one female guest per man is authorized on board at any time.

6. Female guests are subject to a search by the guard matrons of their person and possessions upon entering and leaving the base.

7. All female guests must be logged in and out in the guest log.

8. Authorization must be obtained from the dispensary in order to take guests employees to the dispensary outside of scheduled visiting hours for medical treatment.

9. Infractions are subject to disciplinary action and guest privileges may be revoked.

10. Any exceptions to these regulations must be approved by the Commander Fleet Air Detachment, Binh Thuy, or his representative or higher authority.
