

SUBJECT: Port Call Instructions - Air Travel (CONUS) Sqn # 8-160

SEE DISTRIBUTION

1. Addressee will report to the Americal Division Finance Office 48 hours prior to departure from Cam Ranh Bay for the purpose of processing and to pick up finance records.
2. Upon completion of finance processing, addressee will report to the AG Records Section to outprocess and pick up personnel records.
3. All personnel reporting to finance and records for outprocessing will have in their possession the following items:
 - a. Health & Dental Records
 - b. Clothing Records
 - c. Clearance forms completed and signed by Commanding Officer
4. Upon completion of outprocessing at finance and records sections, personnel will report to the Americal Division Replacement Detachment located at the Americal Division Combat Center near the Americal Beach area for the purpose of obtaining an MTA (DD Form 1482) and transportation to Cam Ranh Bay. Upon arrival at the Replacement Detachment, personnel will have in their possession all required military clothing to include field jacket and all personal baggage for onward movement.
