(C-Jan 73) Items 1-8: (11 pages, handwritten, typewritten, and printed; B-3) Eight personal papers, seven dated between 24 Nov 70 and 3 Oct 72 and the other undated, belonging to Nguyễn Văn Khoát and Trần Công Hùng, members of the 1st Co, 2nd ((Main Force)) Bn, Sub-Region 5 ((aka Thủ Biên Sub-Region, HQ, SVNLA)), consist of the following:

1. Infiltration Pass 017/CTB, undated, signed illegibly, authorizes Nguyễn Văn Khoát, service number B8473.35, Unit D2119 ((possibly Infiltration Group 2119)), to proceed to B9, S9.

Khoát's thumbprints are on the back of the document. The seal reads: "CTB-60, GP".

2. Award notification, dated 30 May 69, signed by Nguyễn Đức Huan, CO of NVA Unit 6966 ((subordination unspecified)), addressed to Nguyễn Văn Khoát's family, reveals that Khoát was selected as an outstanding member for his achievements during the Trường Sơn ((Cordillera)) Troop Movement in 1969. Khoát is a native of Tân Tiến ((Village)), Chuông Mỹ ((District)), Hà Tây ((Province, NVN)).

3. Order 01/QD, dated 4 Mar 71, signed by Trần Văn Mao, CO of J24 ((unidentified)), promotes Nguyễn Văn Khoát, a Combatant in N13 ((unidentified)), to Asst Sqd Ldr.

4. Award certificate, dated 30 Mar 71, signed by Trần Mao, CO of an unspecified unit, reveals that Nguyễn Văn Khoát was granted the title Third Class Determined to Win Warrior.

5. Record, dated 25 May 72, prepared ((possibly by Nguyễn Văn Khoát)), lists the names of his relatives ((living in NVN)), and notes on his biographical data which reveal that he was admitted to the Youth Group in 1958, and started infiltrating ((SVN)) in Mar 68. In May 68, he returned to NVN. He reinfiltated ((SVN)) in Jan 69, and was assigned to K4 ((unidentified)) on an unspecified date. He was transferred to Sub-Region 5 in Jul 69, to Đoan ((Group)) 250 ((unidentified)) on an unspecified date, and to Unit 190 ((possibly the 190th Bn, former VC/NVA C20 Military Region in the Khmer Republic)) in Aug 70. He was reassigned to Sub-Region 3 in Dec 71.

6. Order 12/QDKN, dated 3 Oct 72, signed by Lê Minh Thang, Secretary of the Party Committee of the 2nd ((Main Force)) Bn, Sub-Region 5, admits Nguyễn Văn Khoát of the Party Chapter of the 1st Co, to the Party as a probationary member.

7-8. Two award certificates, dated 24 Nov 70 and 12 Nov 71, signed by Nguyễn Hoa, CO of D190 ((possibly the 190th Bn, former VC/NVA C20 Military Region, presently known as the 2nd Main Force Bn, Thủ Biên Sub-Region)), and by ((Thiếu)), CO of an unspecified unit, reveal that Trần Công Hùng a Sqd Ldr ((in D190)) was granted a Third Class Liberation Combatant Medal, and a letter of appreciation for his combat achievements in a battle on 20 Nov 70.
